## Methodology

This report offers recommendations on Consumer Discretionary sector ETFs and benchmarks for (1) investors considering buying Consumer Discretionary sector ETFs and for (2) comparing individual ETFs to the Consumer Discretionary sector and the S&P 500. Our analysis is based on aggregating results from our models on each of the companies included in every ETF and the overall sector (471 companies) based on data as of April 19<sup>th</sup>, 2011. We aggregate results for the ETFs in the same way the ETFs are designed. Our goal is to empower investors to analyze ETFs in the same way they analyze individual stocks.

To make an informed ETF investment, investors must consider:

- Structural Integrity: ability of an investment vehicle to fulfill its stated objective. We use <u>XTF</u>, an <u>ETF</u> research firm, to find the top 6 Consumer Discretionary sector ETFs with the best structural integrity rating.
- Investment Merit: investment quality of the ETF based on its holdings. We apply our stock rating system to each ETF's holdings to determine its investment merit.

Given the <u>success</u> of our rating system for individual stocks, we believe its application to groups of stocks (i.e. ETFs and funds) helps investors make more informed ETF and mutual fund buying decisions. Barron's featured our unique ETF research in "<u>The Danger Within</u>".

# **Recommendations Summary**

#### If you require exposure to the Consumer Discretionary sector:

We recommend investors buy Retail HOLDRS (RTH). RTH allocates 42% of its value to Attractive-or-better-rated stocks and allocates no value to Dangerous-or-worse-rated stocks. RTH also earns an above-average XTF rating of 9 and an Attractive Overall Risk/Reward Rating.

#### If you require exposure to any other sector:

We recommend investors review our <u>Sector ETF Roadmap</u> report or our <u>9</u> <u>other sector ETF reports</u>, beginning with our Consumer Staples and Health Care sector reports, which are the only other sectors to earn an Attractive Overall Risk/Reward rating.

# If you require exposure to a Consumer Discretionary ETF or an index ETF:

We recommend investors buy the following Consumer Discretionary ETFs over an S&P 500 ETF: RTH and XLY.



#### Recommendations Detail

If you want to be in a sector ETF, the Consumer Staples, Consumer Discretionary and Health Care sectors are the best places to shop due to their Attractive Overall Risk/Reward ratings. Figure 2 shows how the Consumer Discretionary sector's stocks and the market value attributed to them stack up under the microscope of our risk/reward rating system.

The Consumer Discretionary sector has 26% of its value invested in Dangerous-or-worse-rated stocks and 36% of its value invested in Attractive-or-better-rated stocks. The Consumer Discretionary sector's heavy allocation to Attractive-or-better-rated stocks creates opportunities for Attractive-or-better-rated ETFs. Despite this fact, there is only one Attractive-rated ETF.

The key takeaway is that the Consumer Discretionary sector offers both good and poor investment opportunities. The value of each ETF is derived from its constituents, so ETFs like RTH that overweight Attractive-orbetter-rated stocks are great investment opportunities while ETFs like XHB that overweight Neutral-or-worse-rated stocks should be avoided or sold short.

When analyzing the Consumer Discretionary sector ETFs, we started by identifying those ETFs with acceptable structural integrity as measured by XTF. We chose the 6 ETFs with an XTF rating above the sector average XTF rating where we cover at least 90% of the value of the ETF. Figure 3 clearly shows that not all Consumer Discretionary ETFs are made the same. Different ETFs have meaningfully different numbers of holdings and, therefore, different allocations to holdings. Given the differences in holdings and allocations, these ETFs will likely perform quite differently.

After determining the structural integrity, we analyzed the investment merit of each ETF based on how it allocates value to each stock it holds. Figure 4 shows how the 6 Consumer Discretionary sector ETFs stack up versus each other, the overall sector, and the S&P 500 based on their Overall Risk/Reward ratings and the allocation of their holdings by rating.

#### **Attractive ETFs:**

RTH is the only Consumer Discretionary ETF to earn an Attractive Overall Risk/Reward rating and therefore, is the only Consumer Discretionary ETF we recommend.

#### **Neutral ETFs:**

XLY, VCR, PBS, and XRT allocate the value of their funds in a way that earns them a Neutral Overall Risk/Reward rating. We recommend investors buy the Very Attractive and Attractive stocks in this sector before buying any of the Consumer Discretionary ETFs except RTH. Contact us for the full list of 102 Consumer Discretionary companies that earn an Attractive-or-better Overall Risk/Reward rating.

#### **Dangerous ETFs:**




Figure 5: Attractive and Dangerous Consumer Discretionary Sector ETFs

We recommend investors avoid or sell short XHB because of its Dangerous Overall Risk/Reward rating. Figure 5 contrasts the difference in investment merit between RTH, XHB and the overall sector.

### **Benchmark Comparisons**

#### Sector Benchmark

RTH's ratings are the same as the overall sector's ratings, except for Price-to-EBV and GAP. RTH has a significantly shorter GAP than the overall sector (11 years versus the sector's 29-year GAP), earning it a Neutral rating. However, RTH has a higher Price-to-EBV compared to the sector (1.5 versus the sector's 1.1 Price-to-EBV).

RTH more effectively allocates capital than the overall Consumer Discretionary sector. Per <u>Figure 4</u> above, RTH allocates 42% of its value to Attractive-or-better-rated stocks while the sector only allocates 36%. RTH also allocates none of its value toward Dangerous-or-worse-rated stocks compared to the sector's Dangerous-or-worse weightings of 26%.

#### Market Benchmark

RTH outperforms the S&P 500 in valuation ratings. RTH earns an Attractive FCF Yield rating compared to the S&P 500's Neutral rating. RTH also has a Neutral GAP rating compared to the S&P 500's Dangerous GAP rating.

RTH has similar quality of earnings ratings compared to the S&P 500. RTH's market-weighted ROIC of 11.8% earns it an Attractive rating while the S&P 500's market-weighted ROIC of 18.3% earns it a Very Attractive rating.

RTH allocates capital more effectively than the S&P 500. Per Figure 4 above, RTH allocates none of its value to Dangerous-or-worse-rated stocks while the S&P 500 allocates 24%. RTH and the S&P 500 similarly allocate capital to Attractive-or-better-rated stocks.

# Appendix: Risk/Reward Rating System

Our Risk/Reward Rating System assigns a rating to every stock we cover according to what we believe are the 5 most important criteria for assessing the risk versus reward of stocks. See table that follows for details.
