

# ETF & Mutual Fund Rankings: Information Technology Sector

The Information Technology sector ranks fourth out of the ten sectors as detailed in our <u>2Q17 Sector Ratings for</u> <u>ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Information Technology sector ranked third. It gets our Neutral rating, which is based on an aggregation of ratings of 29 ETFs and 142 mutual funds in the Information Technology sector as of April 10, 2017. See a recap of our <u>1Q17 Sector Ratings here</u>.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Information Technology sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 25 to 367). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Information Technology sector should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

Our <u>robo-analyst technology</u> empowers our unique <u>ETF and mutual fund rating methodology</u>, which leverages our rigorous analysis of each fund's holdings. We think advisors and investors focused on prudent investment decisions should include analysis of fund holdings in their research process for ETFs and mutual funds.

Oak Associates Black Oak Emerging Technology Fund (BOGSX) and Saratoga Technology & Communications Portfolio (STPIX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

iShares Global Tech ETF (IXN) is the top-rated Information Technology ETF and Fidelity Select Computers Portfolio (FDCPX) is the top-rated Information Technology mutual fund. Both earn a Very Attractive rating.

ARK Innovation ETF (ARKK) is the worst rated Information Technology ETF and Rydex Electronics Fund (RYELX) is the worst rated Information Technology mutual fund. Both earn a Very Dangerous rating.

475 stocks of the 3000+ we cover are classified as Information Technology stocks.

#### The Danger Within




#### PERFORMANCE OF HOLDINGs = PERFORMANCE OF FUND

Respected investors (e.g. Adam Smith, Warren Buffett and Ben Graham) have repeatedly emphasized that accounting results should not be used to value stocks. <u>Economic earnings</u> are what matter because they are:

- 1. Based on the complete set of financial information available.
- 2. Standard for all companies.
- 3. A more accurate representation of the true underlying cash flows of the business.
