ETF & Mutual Fund Rankings: Large Cap Growth Style

The Large Cap Growth style ranks fifth out of the twelve fund styles as detailed in our <u>2Q18 Style Ratings for ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Large Cap Growth style ranked fourth. It gets our Neutral rating, which is based on an aggregation of ratings of 22 ETFs and 712 mutual funds in the Large Cap Growth style as of April 18, 2018. See a recap of our <u>1Q18 Style Ratings here.</u>

Figures 1 and 2 show the best and worst rated ETFs and mutual funds in the style. Not all Large Cap Growth style ETFs and mutual funds are created the same. The number of holdings varies widely (from 21 to 1038). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Large Cap Growth style should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

American Beacon Alpha Quant Quality Fund (AQQIX, AQQYX, AQQPX) and Scharf Global Opportunity Fund (WRLDX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

VictoryShares U.S. Large Cap High Dividend Volatility Weighted Index (CDL) is the top-rated Large Cap Growth ETF and Fidelity SAI U.S. Quality Index Fund (FUQIX) is the top-rated Large Cap Growth mutual fund. Both earn a Very Attractive rating.

PowerShares Dynamic Large Cap Growth Portfolio (PWB) is the worst rated Large Cap Growth ETF and Quaker Strategic Growth Fund (QUAGX) is the worst rated Large Cap Growth mutual fund. PWB earns a Neutral rating and QUAGX earns a Very Unattractive rating.

Put another way, research on fund holdings is necessary due diligence because a fund's performance is only as good as its holdings' performance. 


