ETF & Mutual Fund Rankings: Telecom Services Sector

The Telecom Services sector ranks ninth out of the 11 sectors as detailed in our <u>2Q18 Sector Ratings for ETFs</u> and <u>Mutual Funds</u> report. <u>Last quarter</u>, the Telecom Services sector ranked eighth. It gets our Unattractive rating, which is based on an aggregation of ratings of six ETFs and 12 mutual funds in the Telecom Services sector as of April 10, 2018. See a recap of our <u>1Q18 Sector Ratings here</u>.




Figure 2: Mutual Funds with the Best & Worst Ratings - Top 5

Figure 1 ranks from best to worst the five Telecom Services ETFs that meet our liquidity minimums. Figure 2 ranks from best to worst the six Telecom Services mutual funds that meet our liquidity standards. Not all Telecom Services sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 19 to 57). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Telecom Services sector should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

PFS Wireless Fund (WIREX) and Rydex Series Telecommunications Fund (RYMIX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

iShares Global Telecom ETF (IXP) is the top-rated Telecom Services ETF and Fidelity Select Wireless Portfolio (FWRLX) is the top-rated Telecom Services mutual fund. IXP earns a Very Attractive rating and FWRLX earns an Attractive rating.

iShares U.S. Telecommunications ETF (IYZ) is the worst rated Telecom Services ETF and Fidelity Advisor Telecommunications Fund (FTUAX) is the worst rated Telecom Services mutual fund. Both earn a Very Unattractive rating.

43 stocks of the 3000+ we cover are classified as Telecom Services stocks.




