

ETF & Mutual Fund Rankings: Consumer Cyclicals Sector

The Consumer Cyclicals sector ranks eighth out of the 11 sectors as detailed in our <u>3Q18 Sector Ratings for</u> <u>ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Consumer Cyclicals sector ranked seventh. It gets our Neutral rating, which is based on an aggregation of ratings of the 448 stocks in the Consumer Cyclicals sector as of July 17, 2018. See a recap of our <u>2Q18 Sector Ratings here</u>.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Consumer Cyclicals sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 25 to 372). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Consumer Cyclicals sector should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

Two mutual funds (ICCCX, ICCAX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

FXD is the top-rated Consumer Cyclicals ETF and FBMPX is the top-rated Consumer Cyclicals mutual fund. FXD earns a Very Attractive rating and FBMPX earns an Attractive rating.

IYC is the worst rated Consumer Cyclicals ETF and FCNAX is the worst rated Consumer Cyclicals mutual fund. IYC earns a Neutral rating and FCNAX earns an Unattractive rating.

448 stocks of the 2850+ we cover are classified as Consumer Cyclicals stocks.

Put another way, research on fund holdings is necessary due diligence because a fund's performance is only as good as its holdings' performance. 


