ETF & Mutual Fund Rankings: Real Estate Sector

The Real Estate sector ranks tenth out of the 11 sectors as detailed in our <u>3Q18 Sector Ratings for ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Real Estate sector ranked tenth. It gets our Unattractive rating, which is based on an aggregation of ratings of the 187 stocks in the Real Estate sector as of July 17, 2018. See a recap of our <u>2Q18 Sector Ratings here</u>.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Real Estate sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 20 to 187). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Real Estate sector should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

REM is the top-rated Real Estate ETF and CGMRX is the top-rated Real Estate mutual fund. REM earns a Very Attractive rating and CGMRX earns a Neutral rating.

PPTY is the worst rated Real Estate ETF and RYREX is the worst Real Estate mutual fund. They both earn a Very Unattractive rating.

187 stocks of the 2850+ we cover are classified as Real Estate stocks.




