



## ETF & Mutual Fund Rankings: Real Estate Sector

The Real Estate sector ranks eleventh out of the 11 sectors as detailed in our [1Q19 Sector Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Real Estate sector ranked eleventh. It gets our Very Unattractive rating, which is based on an aggregation of ratings of the 180 stocks in the Real Estate sector as of January 11, 2019. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Real Estate sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 16 to 190). This variation creates drastically different investment implications and, therefore, ratings.

MORT is the top-rated Real Estate ETF and CGMRX is the top-rated Real Estate mutual fund. MORT earns a Very Attractive rating and CGMRX earns a Neutral rating.

SRVR is the worst rated Real Estate ETF and IRSAX is the worst Real Estate mutual fund. They both earn a Very Unattractive rating.

180 stocks of the 2750+ we cover are classified as Real Estate stocks.

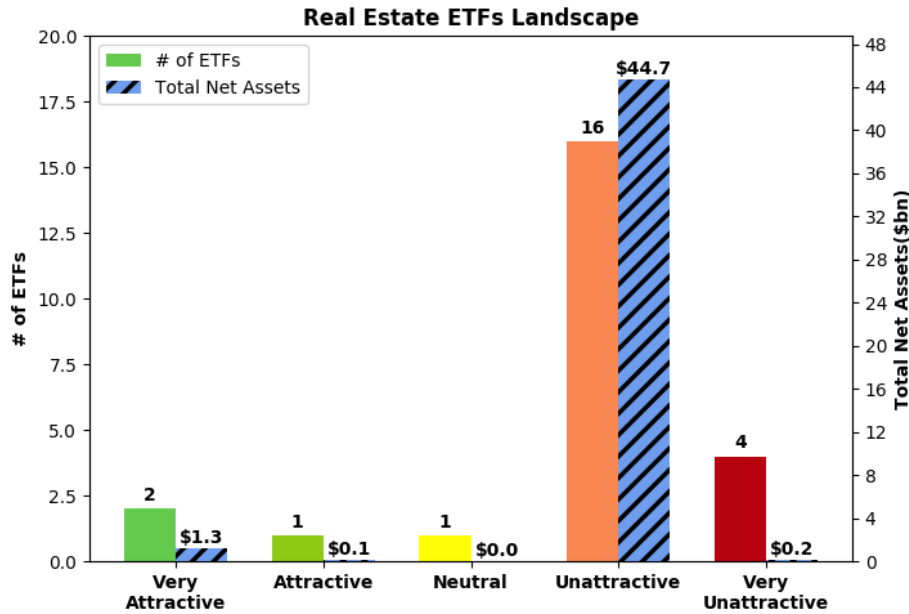

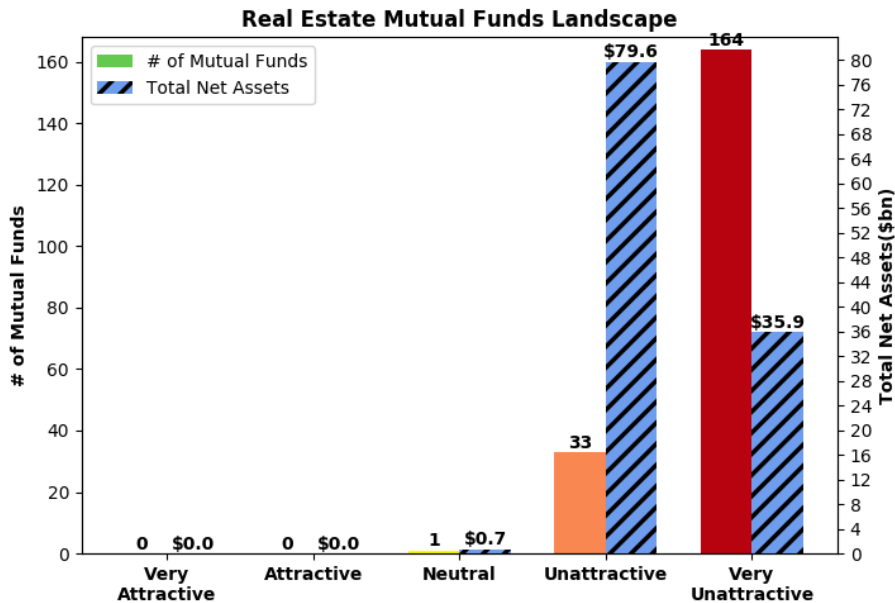
