ETF & Mutual Fund Rankings: Large Cap Growth Style

The Large Cap Growth style ranks fifth out of the twelve fund styles as detailed in our <u>3Q19 Style Ratings for ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Large Cap Growth style ranked sixth. It gets our Neutral rating, which is based on an aggregation of ratings of 24 ETFs and 675 mutual funds in the Large Cap Growth style as of July 15, 2019. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Large Cap Growth style ETFs and mutual funds are created the same. The number of holdings varies widely (from 21 to 576). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Large Cap Growth style should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

Invesco Dynamic Large Cap Growth ETF (PWB) is the top-rated Large Cap Growth ETF and Fidelity SAI U.S. Quality Index Fund (FUQIX) is the top-rated Large Cap Growth mutual fund. PWB earns an Attractive rating and FUQIX earns a Very Attractive rating.

ClearBridge Large Cap Growth ESG ETF (LRGE) is the worst rated Large Cap Growth ETF and PACE Large Company Growth Equity Investments (PLAAX) is the worst rated Large Cap Growth mutual fund. LRGE earns a Neutral rating and PLAAX earns a Very Unattractive rating.



Figure 3: Separating the Best ETFs from the Worst Funds


Large Cap Growth ETF Landscape
