



## ETF & Mutual Fund Rankings: Large Cap Value Style

The Large Cap Value style ranks third out of the twelve fund styles as detailed in our [3Q19 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Large Cap Value style ranked second. It gets our Attractive rating, which is based on an aggregation of ratings of 65 ETFs and 890 mutual funds in the Large Cap Value style as of July 15, 2019. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Large Cap Value style ETFs and mutual funds are created the same. The number of holdings varies widely (from 20 to 1182). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Large Cap Value style should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

FlexShares Quality Dividend Index Fund (QDF) is the top-rated Large Cap Value ETF and Brown Advisory – Beutel Goodman Large Cap Value Fund (BVALX) is the top-rated Large Cap Value mutual fund. Both earn a Very Attractive rating.

Invesco S&P 500 High Dividend Low Volatility ETF (SPHD) is the worst rated Large Cap Value ETF and Transamerica Dividend Focused Fund (TDFAX) is the worst rated Large Cap Value mutual fund. SPHD earns an Unattractive rating and TDFAX earns a Very Unattractive rating.

Put another way, research on fund holdings is necessary due diligence because a fund’s performance is only as good as its holdings’ performance. 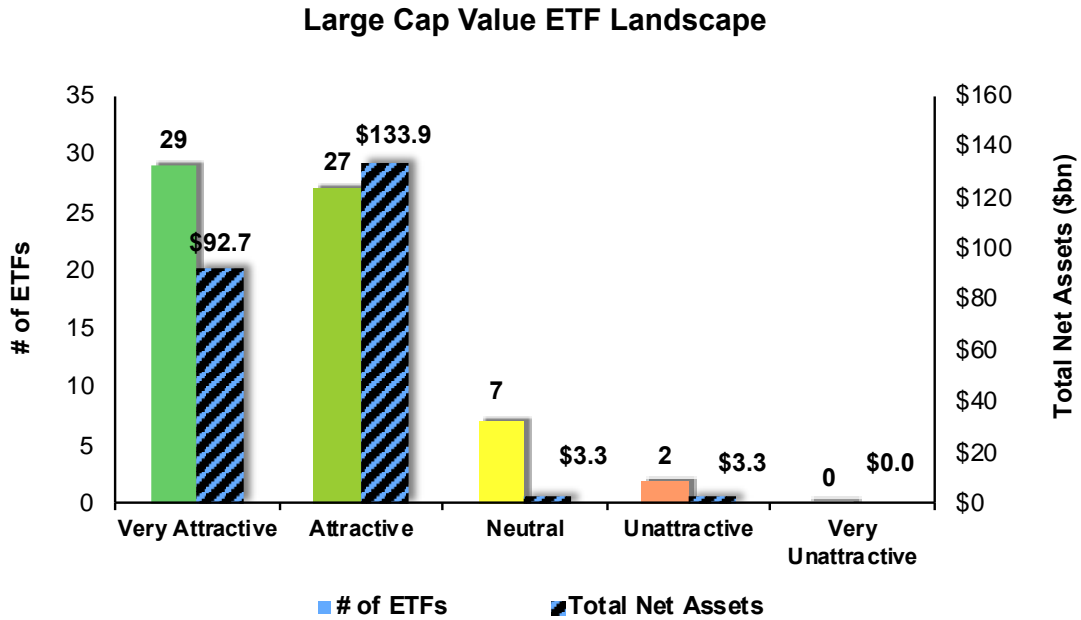

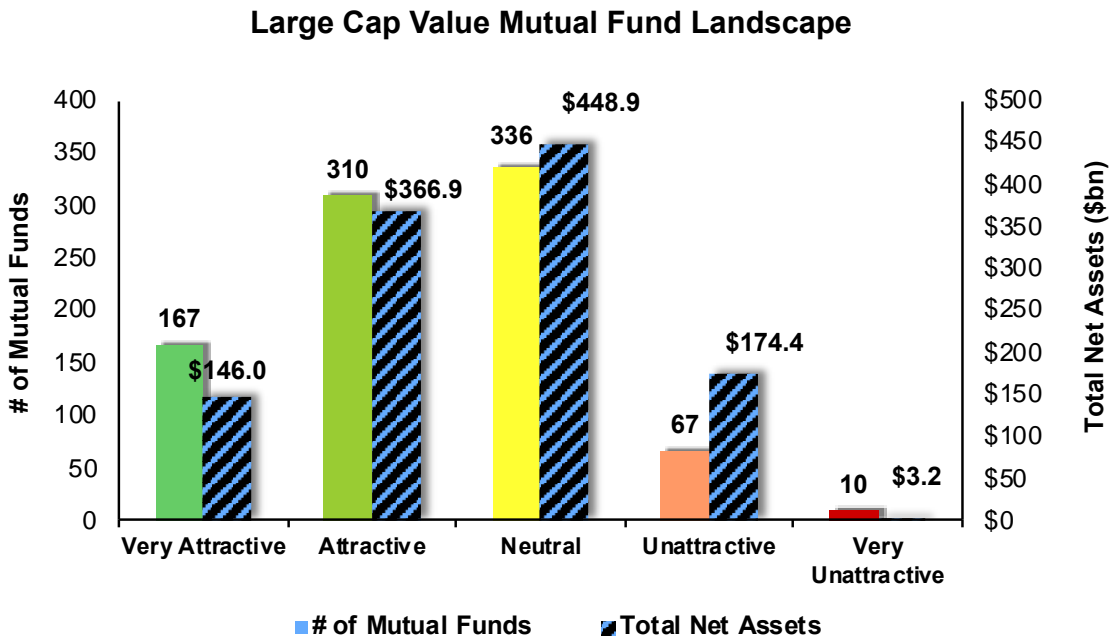
