



ETF & Mutual Fund Rankings: Small Cap Blend Style

The Small Cap Blend style ranks tenth out of the twelve fund styles as detailed in our [3Q19 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Small Cap Blend style ranked tenth as well. It gets our Unattractive rating, which is based on an aggregation of ratings of 48 ETFs and 835 mutual funds in the Small Cap Blend style as of July 15, 2019. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Small Cap Blend style ETFs and mutual funds are created the same. The number of holdings varies widely (from 23 to 3241). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Small Cap Blend style should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

WisdomTree U.S. Small Cap Fund (EES) is the top-rated Small Cap Blend ETF and Royce Small Cap Value Fund (RVVHX) is the top-rated Small Cap Blend mutual fund. Both earn a Very Attractive rating.

Invesco S&P Small cap 600 Equal Weight ETF (EWSC) is the worst rated Small Cap Blend ETF and RBB Fund SGI U.S. Small Cap Equity Fund (LVSMX) is the worst rated Small Cap Blend mutual fund. EWSC earns an Unattractive rating and LVSMX earns a Very Unattractive rating.

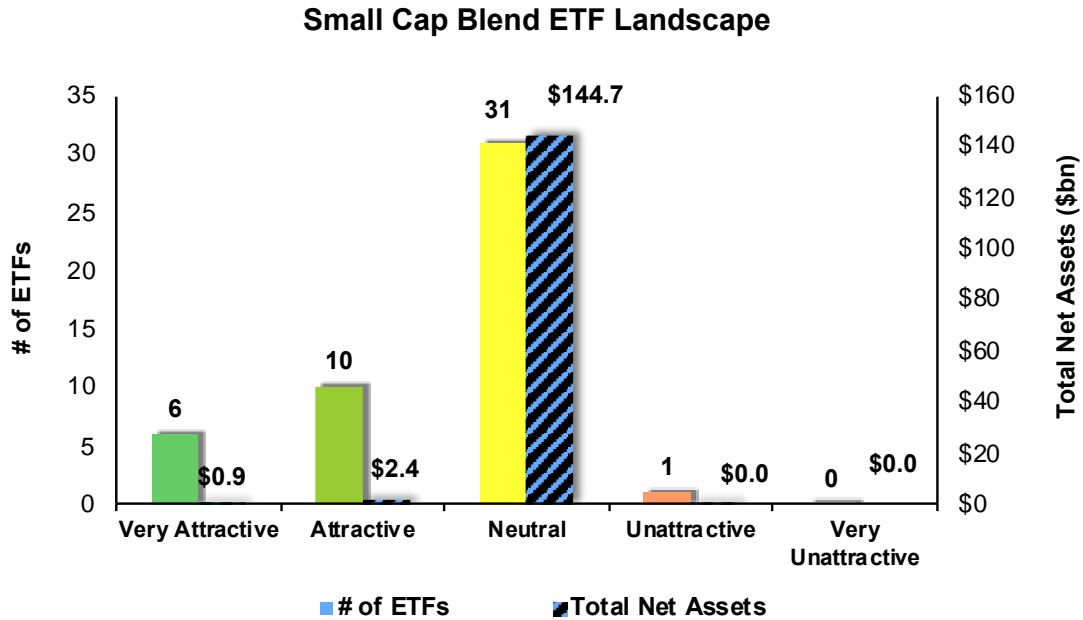

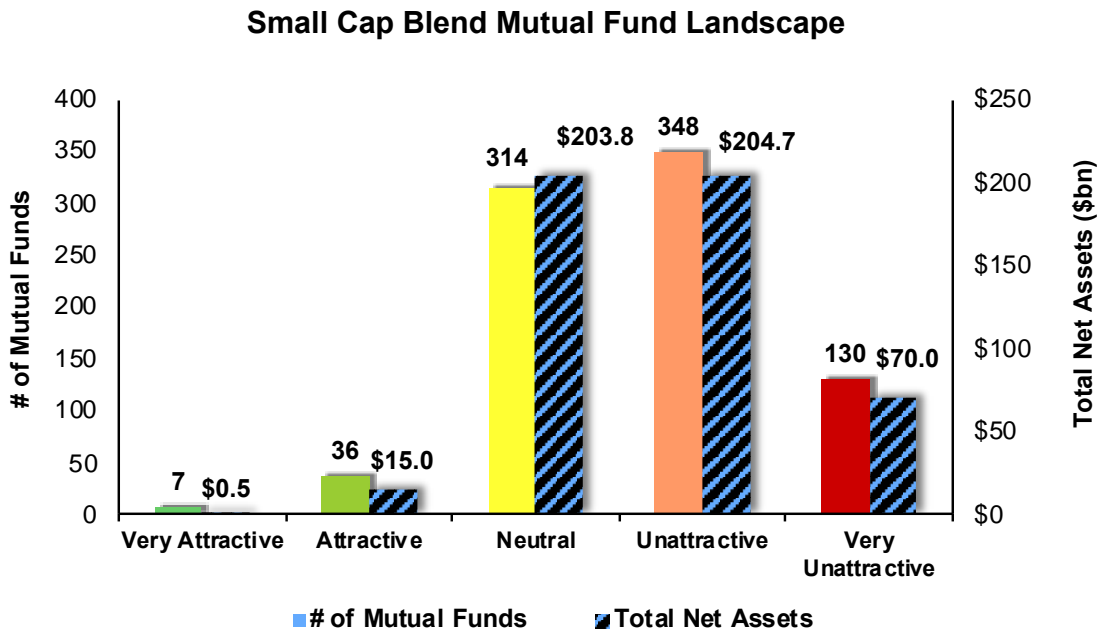
