



ETF & Mutual Fund Rankings: Consumer Non-cyclicals Sector

The Consumer Non-cyclicals sector ranks second out of the 11 sectors as detailed in our [4Q19 Sector Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Consumer Non-cyclicals sector ranked third. It gets our Attractive rating, which is based on an aggregation of ratings of the 137 stocks in the Consumer Non-cyclicals sector as of October 11, 2019. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Consumer Non-cyclicals sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 25 to 124). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Consumer Non-cyclicals sector should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

FSAVX is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

RHS is the top-rated Consumer Non-cyclicals ETF and FIJCX is the top-rated Consumer Non-cyclicals mutual fund. Both earn a Very Attractive rating.

PSL is the worst rated Consumer Non-cyclicals ETF and ICRAX is the worst rated Consumer Non-cyclicals mutual fund. PSL earns a Neutral rating and ICRAX earns an Unattractive rating.

137 stocks of the 2850+ we cover are classified as Consumer Non-cyclicals stocks.

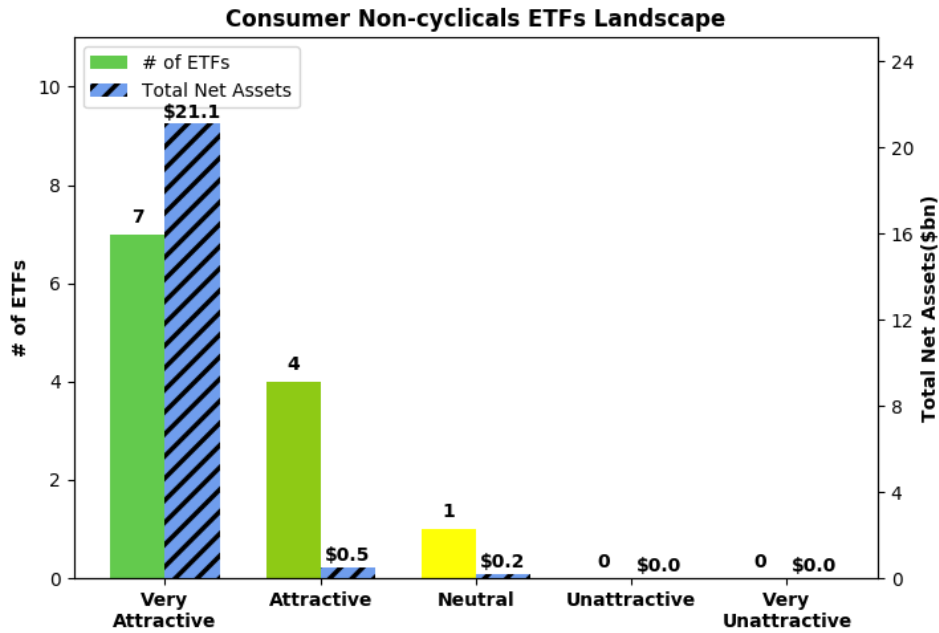

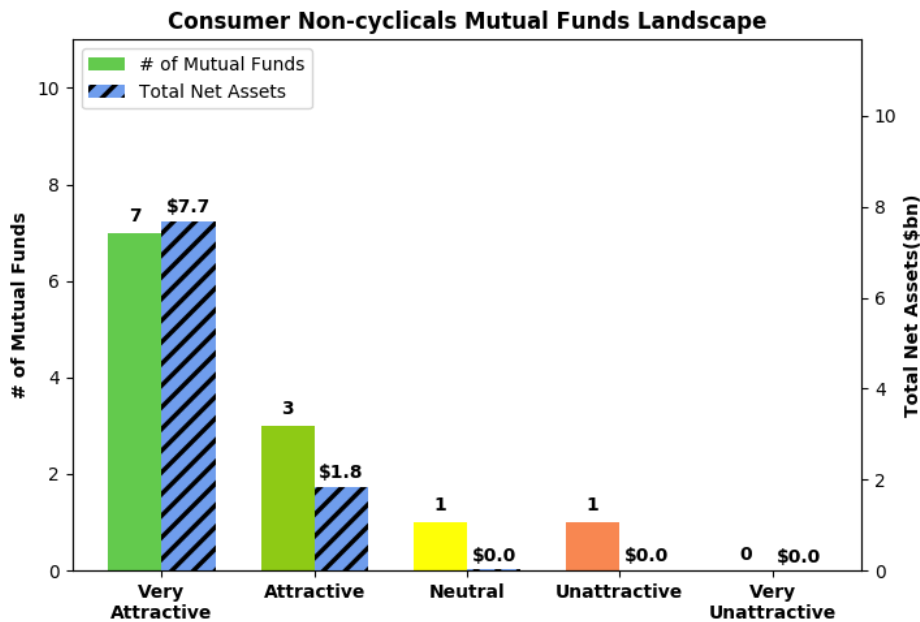
