# **ETF & Mutual Fund Rankings: Technology Sector**

The Technology sector ranks sixth out of the 11 sectors as detailed in our 4Q19 Sector Ratings for ETFs and Mutual Funds report. Last quarter, the Technology sector ranked ninth. It gets our Neutral rating, which is based on an aggregation of ratings of the 456 stocks in the Technology sector as of October 11, 2019. See a recap of our 3Q19 Sector Ratings here.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Technology sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 21 to 380). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Technology sector should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

TDIV is the top-rated Technology ETF and ROGSX is the top-rated Technology mutual fund. Both earn a Very Attractive rating.

ARKW is the worst rated Technology ETF and RSIFX is the worst Technology mutual fund. They both earn a Very Unattractive rating.

456 stocks of the 2850+ we cover are classified as Technology stocks.




