



## ETF & Mutual Fund Rankings: All Cap Growth Style

The All Cap Growth style ranks ninth out of the twelve fund styles as detailed in our [2Q20 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the All Cap Growth style ranked tenth. It gets our Neutral rating, which is based on an aggregation of ratings of 26 ETFs and 570 mutual funds in the All Cap Growth style as of April 21, 2020. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all All Cap Growth style ETFs and mutual funds are created the same. The number of holdings varies widely (from 15 to 2149). This variation creates drastically different investment implications and, therefore, ratings.

American Beacon Alpha Quant Quality Fund (AQQIX, AQQYX, AQQPX) is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

Davis Select Worldwide ETF (DWLD) is the top-rated All Cap Growth ETF and Provident Trust Strategy Fund (PROVX) is the top-rated All Cap Growth mutual fund. Both earn a Very Attractive rating.

First Trust U.S. Equity Opportunities ETF (FPX) is the worst rated All Cap Growth ETF and Virtus Zevenbergen Innovative Growth Stock Fund (SAGAX) is the worst rated All Cap Growth mutual fund. Both earn a Very Unattractive rating.

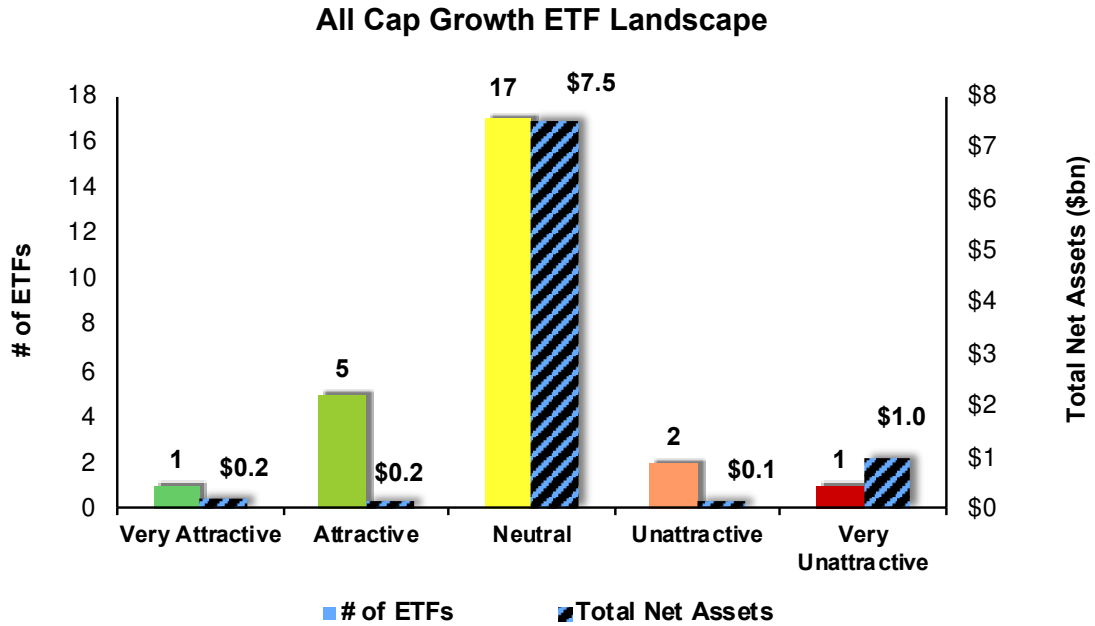

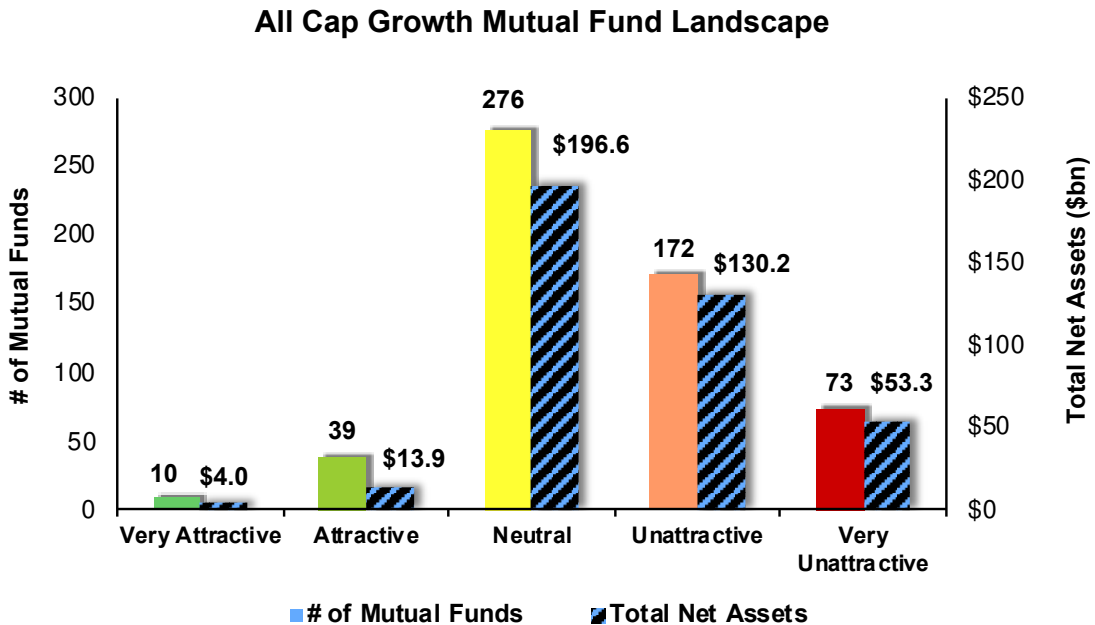


Figure 3: Separating the Best ETFs from the Worst Funds
