Finding the best mutual funds is an increasingly difficult task in a world with so many to choose from. How can you pick with so many choices available?

Don't Trust Mutual Fund Labels

There are at least 826 different Large Cap Value mutual funds and at 6483 mutual funds across twelve styles. Do investors need 540+ choices on average per style? How different can the mutual funds be?

Those 826 Large Cap Value mutual funds are very different. With anywhere from 14 to 804 holdings, many of these Large Cap Value mutual funds have drastically different portfolios, creating drastically different investment implications.

The same is true for the mutual funds in any other style, as each offers a very different mix of good and bad stocks. Large Cap Value ranks first for stock selection. Small Cap Growth ranks last. Details on the [Best & Worst mutual funds in each style are here](#).

How to Avoid Paralysis by Analysis

We think the large number of Large Cap Value (or any other) style mutual funds hurts investors more than it helps because too many options can be paralyzing. It is simply not possible for the majority of investors to properly assess the quality of so many mutual funds. Analyzing mutual funds, done with the proper diligence¹, is far more difficult than analyzing stocks because it means analyzing all the stocks within each mutual fund. As stated above, that can be as many as 804 stocks, and sometimes even more, for one mutual fund.

Anyone focused on [fulfilling the fiduciary duty of care](#) recognizes that analyzing the holdings² of a mutual fund is critical to finding the best mutual fund. Only our research utilizes the superior data and earnings adjustments featured by the Harvard Business School and MIT Sloan paper, "[Core Earnings: New Data and Evidence](#)." Figure 1 shows our top rated mutual fund for each style.

Amongst the mutual funds in Figure 1, Fidelity Advisor Mid Cap Value Fund (FIDFX) ranks first overall, Sterling Capital Behavioral Large Cap Value Equity Fund (STRAX) ranks second, and Franklin Mutual U.S. Value Fund (FBSIX) ranks third. Virtus KAR Small Cap Value Fund (VQSRX) ranks last.

Fidelity Advisor Mid Cap Value Fund (FIDFX) is not only the top-rated Mid Cap Value mutual fund, but is also the overall top-ranked style mutual fund out of the 6483 style mutual funds that we cover.

All the mutual funds in Figure 1 earn an Attractive-or-better rating. However, with so many Neutral-or-worse rated funds under coverage, one would think mutual fund providers could do better.
