# ETF & Mutual Fund Rankings: All Cap Value Style

The All Cap Value style ranks second out of the twelve fund styles as detailed in our <u>3Q20 Style Ratings for</u> <u>ETFs and Mutual Funds</u> report. Last quarter, the All Cap Value style ranked second as well. It gets our Attractive rating, which is based on an aggregation of ratings of 47 ETFs and 492 mutual funds in the All Cap Value style as of July 21, 2020. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all All Cap Value style ETFs and mutual funds are created the same. The number of holdings varies widely (from 17 to 1658). This variation creates drastically different investment implications and, therefore, ratings.

VictoryShares U.S. Multi-Factor Minimum Volatility ETF (VSMV) is the top-rated All Cap Value ETF and Fidelity Blue Chip Value Fund (FBCVX) is the top-rated All Cap Value mutual fund. Both earn a Very Attractive rating.

VictoryShares USAA MSCI USA Value Momentum ETF (ULVM) is the worst rated All Cap Value ETF and American Pension Investors Yorktown Capital Income Fund (APIGX) is the worst rated All Cap Value mutual fund. ULVM earns a Neutral rating and APIGX earns an Unattractive rating.

Put another way, research on fund holdings is necessary due diligence because a fund's performance is only as good as its holdings' performance. 
### PERFORMANCE OF HOLDINGs = PERFORMANCE OF FUND


