

ETF & Mutual Fund Rankings: Consumer Cyclicals Sector

The Consumer Cyclicals sector ranks ninth out of the 11 sectors as detailed in our <u>3Q20 Sector Ratings for ETFs</u> and <u>Mutual Funds</u> report. <u>Last quarter</u>, the Consumer Cyclicals sector ranked ninth. It gets our Unattractive rating, which is based on an aggregation of ratings of the 449 stocks in the Consumer Cyclicals sector as of July 11, 2020. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Consumer Cyclicals sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 23 to 294). This variation creates drastically different investment implications and, therefore, ratings.

ICCCX is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

XHB is the top-rated Consumer Cyclicals ETF and FDLSX is the top-rated Consumer Cyclicals mutual fund. XHB earns a Very Attractive rating and FDLSX earns a Neutral rating.

BUYZ is the worst rated Consumer Cyclicals ETF and ICCAX is the worst rated Consumer Cyclicals mutual fund. BUYZ earns a Very Unattractive rating and ICCAX earns an Unattractive rating.

449 stocks of the 2850+ we cover are classified as Consumer Cyclicals stocks.




