

# ETF & Mutual Fund Rankings: Large Cap Blend Style

The Large Cap Blend style ranks third out of the twelve fund styles as detailed in our <u>3Q20 Style Ratings for</u> <u>ETFs and Mutual Funds</u> report. Last quarter, the Large Cap Blend style ranked third as well. It gets our Attractive rating, which is based on an aggregation of ratings of 61 ETFs and 664 mutual funds in the Large Cap Blend style as of July 22, 2020. Figures 1 and 2 show the best and worst rated ETFs and mutual funds in the style. Not all Large Cap Blend style ETFs and mutual funds are created the same. The number of holdings varies widely (from 14 to 1801). This variation creates drastically different investment implications and, therefore, ratings.

Scharf Global Opportunity Fund (WRLDX) is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

WisdomTree U.S. LargeCap Fund (EPS) is the top-rated Large Cap Blend ETF and State Farm Growth Fund (STFGX) is the top-rated Large Cap Blend mutual fund. Both earn a Very Attractive rating.

HCM Defender 100 Index (QQH) is the worst rated Large Cap Blend ETF and Virtus Rampart Sector Trend Fund (PWBAX) is the worst rated Large Cap Blend mutual fund. QQH earns a Neutral rating and PWBAX earns an Unattractive rating.

Buying a fund without analyzing its holdings is like buying a stock without analyzing its business and finances. Put another way, research on fund holdings is necessary due diligence because a fund's performance is only as good as its holdings' performance. 






Figures 3 and 4 show the rating landscape of all Large Cap Blend ETFs and mutual funds.
