



## ETF & Mutual Fund Rankings: Small Cap Value Style

The Small Cap Value style ranks eighth out of the twelve fund styles as detailed in our [3Q20 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Small Cap Value style ranked eighth as well. It gets our Neutral rating, which is based on an aggregation of ratings of 19 ETFs and 182 mutual funds in the Small Cap Value style as of July 23, 2020. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Small Cap Value style ETFs and mutual funds are created the same. The number of holdings varies widely (from 27 to 1465). This variation creates drastically different investment implications and, therefore, ratings.

Avantais U.S. Small Cap Value ETF (AVUV) is the top-rated Small Cap Value ETF and Franklin Small Cap Value Fund (FRSCX) is the top-rated Small Cap Value mutual fund. Both earn an Attractive rating.

Invesco S&P Small Cap 600 Pure Value ETF (RZV) is the worst rated Small Cap Value ETF and Pace Small/Medium Co Value Equity Investments (PEVAX) is the worst rated Small Cap Value mutual fund. RZV earns an Unattractive rating and PEVAX earns a Very Unattractive rating.

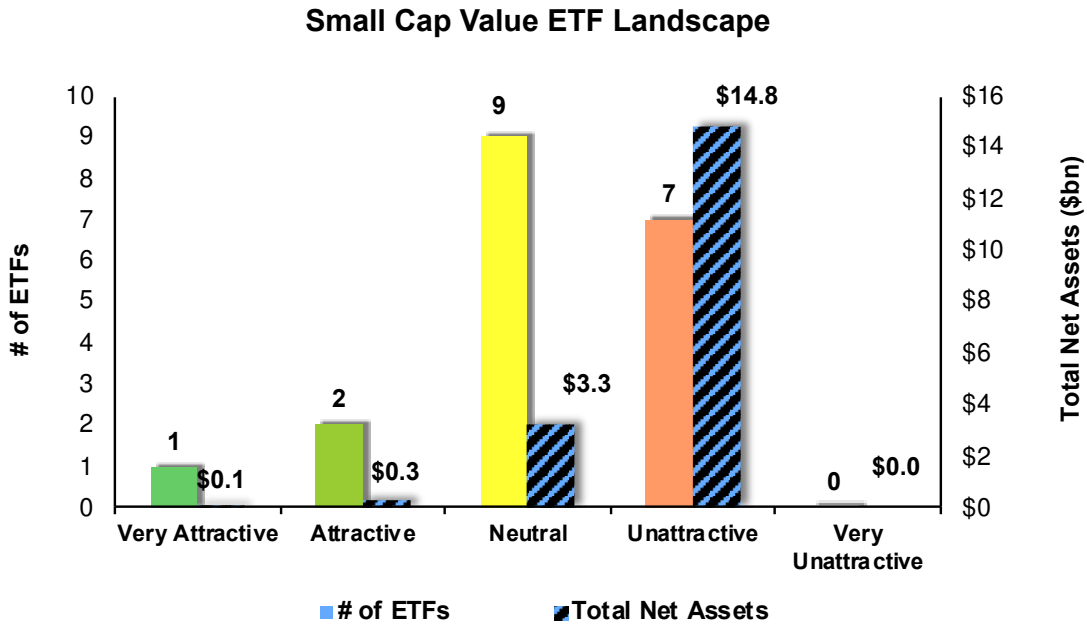

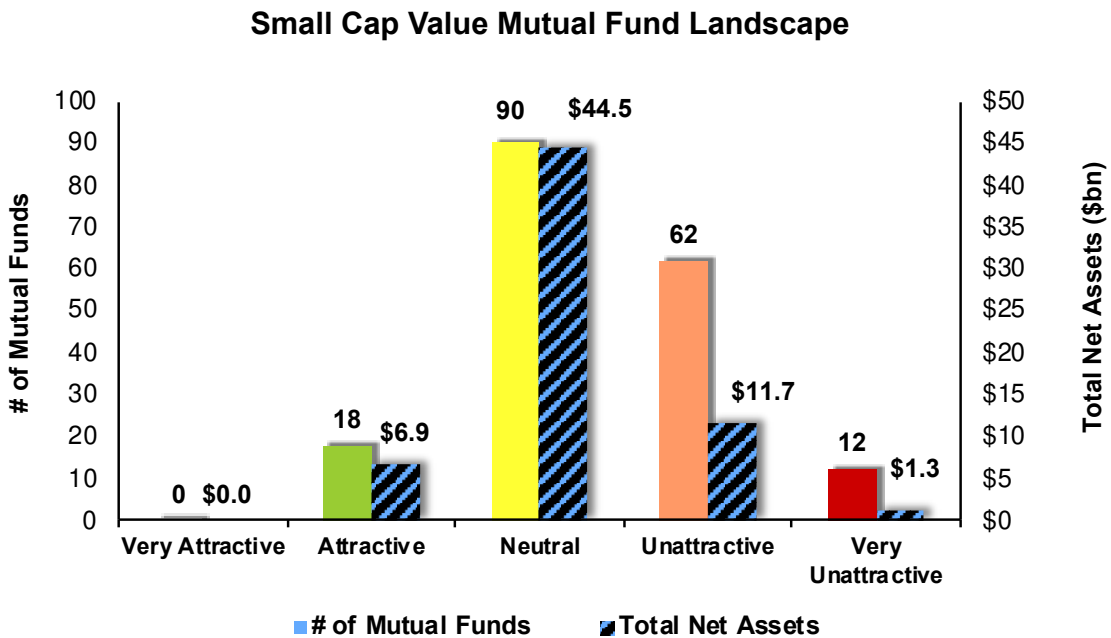
