ETF & Mutual Fund Rankings: All Cap Value Style

The All Cap Value style ranks third out of the twelve fund styles as detailed in our <u>4Q20 Style Ratings for ETFs</u> and <u>Mutual Funds</u> report. <u>Last quarter</u>, the All Cap Value style ranked second. It gets our Attractive rating, which is based on an aggregation of ratings of 49 ETFs and 550 mutual funds in the All Cap Value style as of October 19, 2020. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all All Cap Value style ETFs and mutual funds are created the same. The number of holdings varies widely (from 15 to 2198). This variation creates drastically different investment implications and, therefore, ratings.

Fidelity Advisor Value Leaders Fund (FVLIX, FVLCX) is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

American Century STOXX U.S. Quality Value ETF (VALQ) is the top-rated All Cap Value ETF and Fidelity Blue Chip Value Fund (FBCVX) is the top-rated All Cap Value mutual fund. Both earn a Very Attractive rating.

First Trust U.S. Equity Dividend Select ETF (RNDV) is the worst rated All Cap Value ETF and PFS Castle Focus Fund (CASTX) is the worst rated All Cap Value mutual fund. RNDV earns a Neutral rating and CASTX earns a Very Unattractive rating.



Figure 3: Separating the Best ETFs from the Worst Funds


All Cap Value ETF Landscape
