



ETF & Mutual Fund Rankings: Financials Sector

The Financials sector ranks second out of the 11 sectors as detailed in our [4Q20 Sector Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Financials sector ranked third. It gets our Attractive rating, which is based on an aggregation of ratings of the 429 stocks in the Financials sector as of October 12, 2020. See a recap of our [3Q20 Sector Ratings here](#).

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Financials sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 21 to 415). This variation creates drastically different investment implications and, therefore, ratings.

Four mutual funds (HISFX, HSFNX, RYKIX, RYKAX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

KBWP is the top-rated Financials ETF and FSRBX is the top-rated Financials mutual fund. Both earn a Very Attractive rating.

KBWD is the worst rated Financials ETF and RYFNX is the worst Financials mutual fund. They both earn an Unattractive rating.

429 stocks of the 2850+ we cover are classified as Financials stocks.

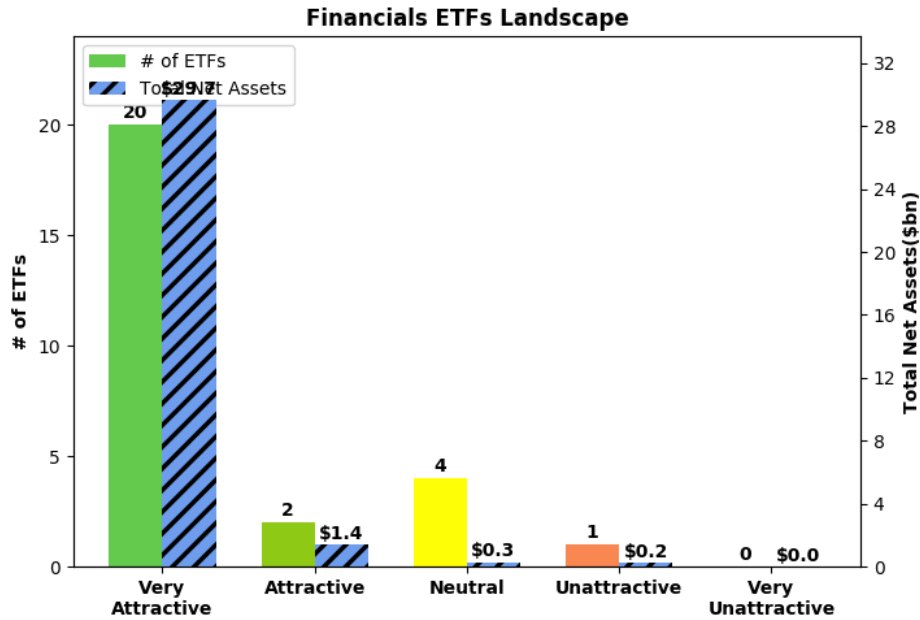

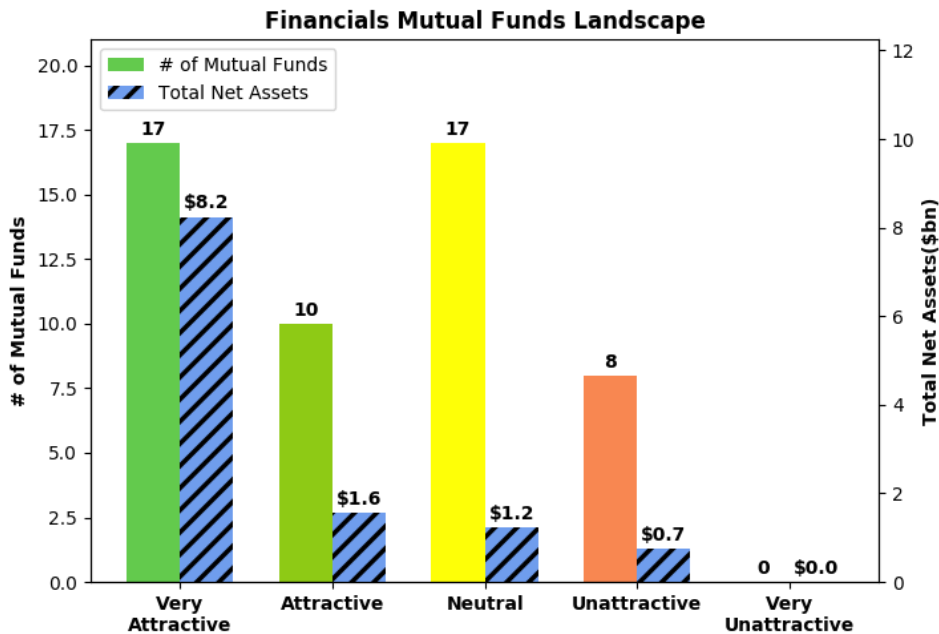
