



ETF & Mutual Fund Rankings: Real Estate Sector

The Real Estate sector ranks eleventh out of the 11 sectors as detailed in our [4Q20 Sector Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Real Estate sector ranked eleventh. It gets our Very Unattractive rating, which is based on an aggregation of ratings of the 198 stocks in the Real Estate sector as of October 12, 2020. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Real Estate sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 17 to 180). This variation creates drastically different investment implications and, therefore, ratings.

CGMRX is the top-rated Real Estate mutual fund. There are no ETFs that receive a Neutral-or-better rating. CGMRX earns a Very Attractive rating.

INDS is the worst rated Real Estate ETF and DAREX is the worst Real Estate mutual fund. They both earn a Very Unattractive rating.

198 stocks of the 2850+ we cover are classified as Real Estate stocks.

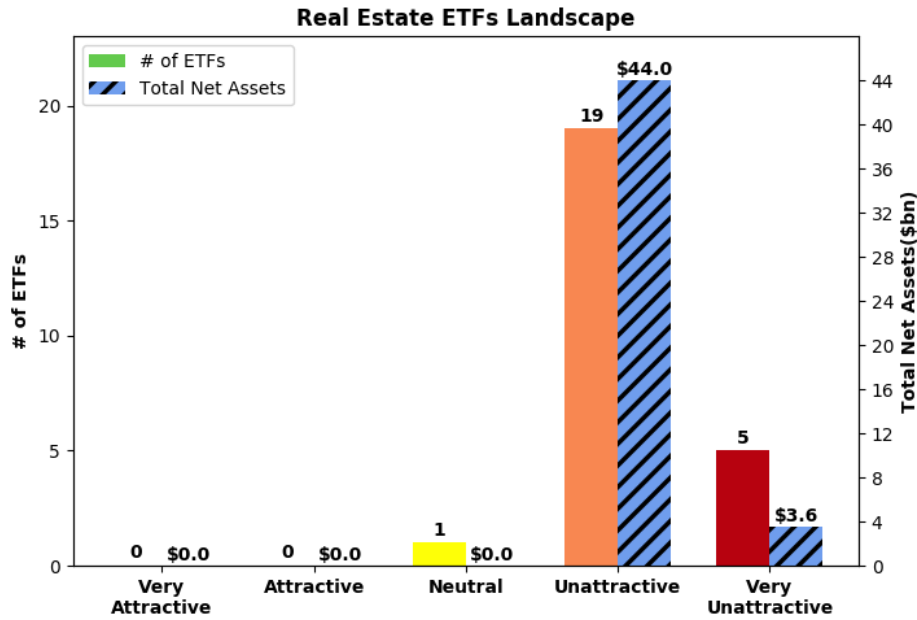

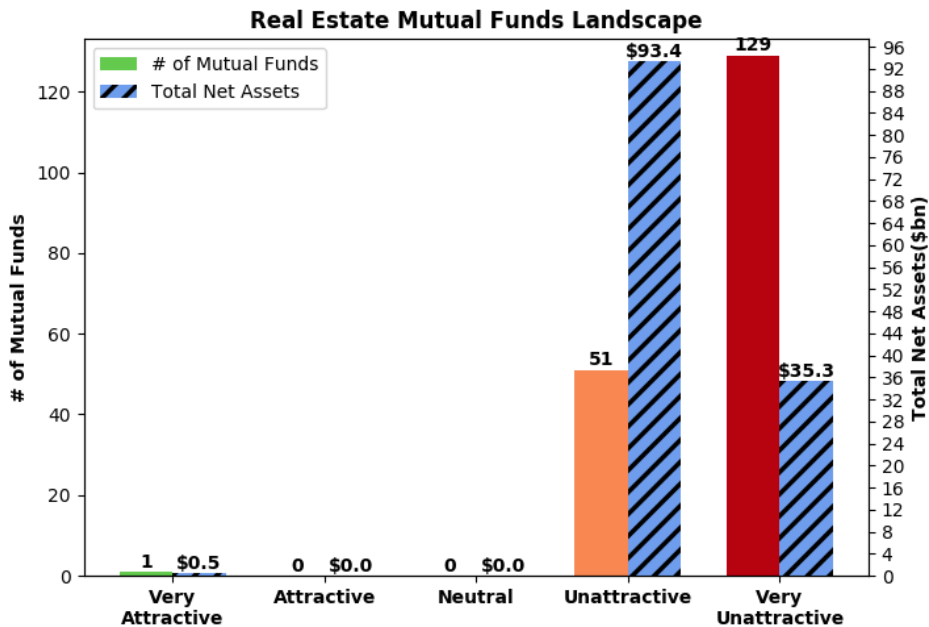
