



ETF & Mutual Fund Rankings: Mid Cap Value Style

The Mid Cap Value style ranks seventh out of the twelve fund styles as detailed in our [1Q21 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Mid Cap Value style ranked fifth. It gets our Neutral rating, which is based on an aggregation of ratings of 11 ETFs and 143 mutual funds in the Mid Cap Value style as of January 21, 2020. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Mid Cap Value style ETFs and mutual funds are created the same. The number of holdings varies widely (from 22 to 794). This variation creates drastically different investment implications and, therefore, ratings.

Fidelity Mid Cap Value K6 Fund (FCMVX) is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

[Alpha Architect U.S. Quantitative Value ETF](#) (QVAL) is the top-rated Mid Cap Value ETF and Fidelity Advisor Mid Cap Value Fund (FIDFX) is the top-rated Mid Cap Value mutual fund. Both earn a Very Attractive rating.

Nuveen ESG Mid Cap Value ETF (NUMV) is the worst rated Mid Cap Value ETF and Transamerica Small/Mid Cap Value Fund (IIVAX) is the worst rated Mid Cap Value mutual fund. NUMV earns an Unattractive rating and IIVAX earns a Very Unattractive rating.

Put another way, research on fund holdings is necessary due diligence because a fund's performance is only as good as its holdings' performance. 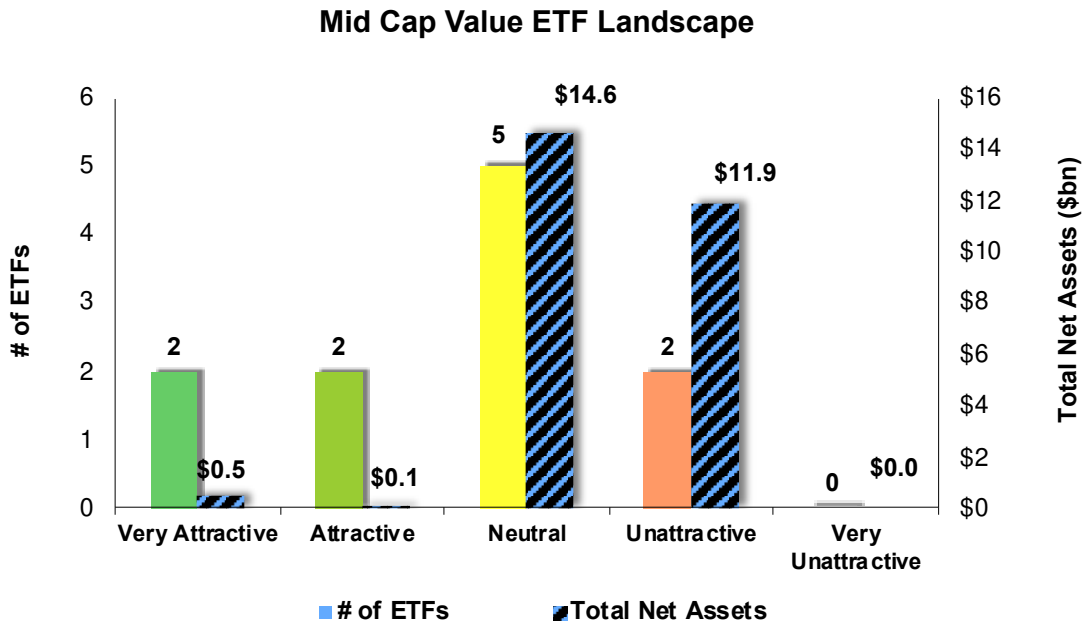

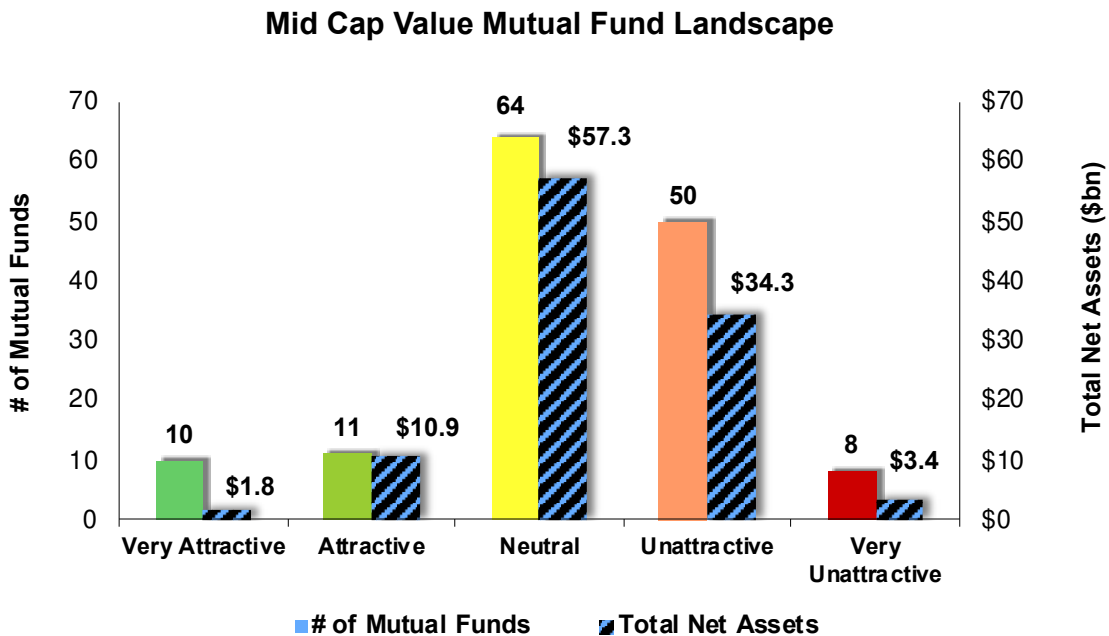
