ETF & Mutual Fund Rankings: All Cap Blend Style

The All Cap Blend style ranks third out of the twelve fund styles as detailed in our <u>2Q21 Style Ratings for ETFs</u> and <u>Mutual Funds</u> report. <u>Last quarter</u>, the All Cap Blend style ranked third as well. It gets our Attractive rating, which is based on an aggregation of ratings of 147 ETFs and 717 mutual funds in the All Cap Blend style as of April 19, 2021. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all All Cap Blend style ETFs and mutual funds are created the same. The number of holdings varies widely (from 16 to 3636). This variation creates drastically different investment implications and, therefore, ratings.

Nine mutual funds (HRURX, HRUNX, HRUVX, VGQRX, GWILX, PIPTX, PMPIX, PPTCX, BKPIX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

Invesco BLDRs Emerging Markets 50 ADR Index Fund (ADRE) is the top-rated All Cap Blend ETF and AQR Large Cap Multi-Style Fund (QCERX) is the top-rated All Cap Blend mutual fund. Both earn a Very Attractive rating.

ETFMG Alternative Harvest ETF (MJ) is the worst rated All Cap Blend ETF and American Growth Cannabis Fund (AMREX) is the worst rated All Cap Blend mutual fund. Both earn a Very Unattractive rating.

Buying a fund without analyzing its holdings is like buying a stock without analyzing its business and finances. Put another way, research on fund holdings is necessary due diligence because a fund's performance is only as good as its holdings' performance. 
PERFORMANCE OF HOLDINGs = PERFORMANCE OF FUND




