



## How to Avoid the Worst Style ETFs

Question: Why are there so many ETFs?

Answer: ETF providers tend to make lots of money on each ETF so they create more products to sell.

The large number of ETFs has little to do with serving your best interests. More reliable & [proprietary](#) fundamental data, proven in [The Journal of Financial Economics](#), drives our research and analysis of ETF holdings. We leverage this data to identify three red flags you can use to avoid the worst ETFs:

### 1. Inadequate Liquidity

This issue is the easiest issue to avoid, and our advice is simple. Avoid all ETFs with less than \$100 million in assets. Low levels of liquidity can lead to a discrepancy between the price of the ETF and the underlying value of the securities it holds. Plus, low asset levels tend to mean lower volume in the ETF and larger bid-ask spreads.

### 2. High Fees

ETFs should be cheap, but not all of them are. The first step here is to know what is cheap and expensive.

To ensure you are paying at or below average fees, invest only in ETFs with [total annual costs](#) below 0.45%, which is the average total annual cost of the 573 U.S. equity Style ETFs we cover. The weighted average is lower at 0.14%, which highlights how investors tend to put their [money in ETFs with low fees](#).

Figure 1 shows WBI BullBear Value 3000 ETF (WBIF) is the most expensive style ETF and JPMorgan BetaBuilders U.S. Equity ETF (BBUS) is the least expensive. Absolute Shares Trust (WBIF, WBIE, WBIL, WBIG) provides four of the most expensive ETFs while JP Morgan provides the cheapest (BBUS).

Investors need not pay high fees for quality holdings.<sup>1</sup> JPMorgan BetaBuilders U.S. Equity ETF (BBUS) has low costs and quality holdings. BBUS's Neutral [Portfolio Management rating](#) and 0.03% total annual cost earn it an

Attractive rating.<sup>2</sup> [FlexShares Quality Dividend Index Fund](#) (QDF) is the best ranked style ETF overall. QDF's Attractive Portfolio Management rating and 0.41% total annual cost also earn it a Very Attractive rating.

On the other hand, no matter how cheap an ETF, if it holds bad stocks, its performance will be bad. The quality of an ETF's holdings matters more than its price.

### 3. Poor Holdings

Avoiding poor holdings is by far the hardest part of avoiding bad ETFs, but it is also the most important because an ETF's performance is determined more by its holdings than its costs. Figure 2 shows the ETFs within each style with the worst holdings or [portfolio management ratings](#).

Invesco (SPHB & RDIV) and Vanguard (VOE & VTWV) appear more often than any other providers in Figure 2, which means that they offer the most ETFs with the worst holdings.

ERShares Entrepreneurs ETF (ENTR) is the worst rated ETF in Figure 2. ETF Managers ETFMG Alternative Harvest ETF (MJ) and MFAM Small Cap Growth ETF (MFMS) also earn a Very Unattractive [predictive overall rating](#), which means not only do they hold poor stocks, they charge high total annual costs.

Our [overall ratings on ETFs](#) are on our [stock ratings](#) of their holdings and the total annual costs of investing in the ETF.

### The Danger Within

Buying an ETF without analyzing its holdings is like buying a stock without analyzing its business and finances. Put another way, research on ETF holdings is necessary due diligence because an ETF's performance is only as good as its holdings' performance.
