ETF & Mutual Fund Rankings: Mid Cap Blend Style

The Mid Cap Blend style ranks sixth out of the twelve fund styles as detailed in our <u>2Q21 Style Ratings for ETFs</u> and <u>Mutual Funds</u> report. <u>Last quarter</u>, the Mid Cap Blend style ranked sixth as well. It gets our Neutral rating, which is based on an aggregation of ratings of 29 ETFs and 317 mutual funds in the Mid Cap Blend style as of April 21, 2021. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Mid Cap Blend style ETFs and mutual funds are created the same. The number of holdings varies widely (from 20 to 2378). This variation creates drastically different investment implications and, therefore, ratings.

Seven mutual funds (RSIYX, RSIKX, RIVCX, WAMFX, WASMX, AADGX, HEQCX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

Invesco S&P Mid Cap Quality ETF (XMHQ) is the top-rated Mid Cap Blend ETF and Touchstone Mid Cap Fund (TMPRX) is the top-rated Mid Cap Blend mutual fund. Both earn a Very Attractive rating.

Invesco Raymond James SB-1 Equity ETF (RYJ) is the worst rated Mid Cap Blend ETF and Donoghue Forlines Momentum Fund (MOJAX) is the worst rated Mid Cap Blend mutual fund. RYJ earns an Unattractive rating and MOJAX earns a Very Unattractive rating.






Figures 3 and 4 show the rating landscape of all Mid Cap Blend ETFs and mutual funds.
