ETF & Mutual Fund Rankings: All Cap Blend Style

The All Cap Blend style ranks third out of the twelve fund styles as detailed in our <u>3Q21 Style Ratings for ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the All Cap Blend style ranked third as well. It gets our Attractive rating, which is based on an aggregation of ratings of 144 ETFs and 732 mutual funds in the All Cap Blend style as of July 14, 2021. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all All Cap Blend style ETFs and mutual funds are created the same. The number of holdings varies widely (from 16 to 3,636). This variation creates drastically different investment implications and, therefore, ratings.

JPMorgan Equity Premium Income ETF (JEPI) is the top-rated All Cap Blend ETF and FormulaFolios U.S. Equity Fund (FFILX) is the top-rated All Cap Blend mutual fund. Both earn a Very Attractive rating.

ProShares Ultra Oil & Gas (DIG) is the worst rated All Cap Blend ETF and Oil Equipment & Services UltraSector ProFund (OEPSX) is the worst rated All Cap Blend mutual fund. Both earn a Very Unattractive rating.



Figure 3: Separating the Best ETFs from the Worst Funds


All Cap Blend ETF Landscape
