# **ETF & Mutual Fund Rankings: Basic Materials Sector**

The Basic Materials sector ranks second out of the 11 sectors as detailed in our <u>3Q21 Sector Ratings for ETFs</u> and <u>Mutual Funds</u> report. <u>Last quarter</u>, the Basic Materials sector ranked fourth. It gets our Attractive rating, which is based on an aggregation of ratings of the 153 stocks in the Basic Materials sector as of July 11, 2021. See a recap of our <u>2Q21 Sector Ratings here</u>.

Figures 1 and 2 show the best and worst rated ETFs and mutual funds in the sector. Not all Basic Materials sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 24 to 115). This variation creates drastically different investment implications and, therefore, ratings.

SLX is the top-rated Basic Materials ETF and VMIAX is the top-rated Basic Materials mutual fund. SLX earns an Attractive rating and VMIAX earns a Neutral rating.

XME is the worst rated Basic Materials ETF and FMFAX is the worst Basic Materials mutual fund. They both earn an Unattractive rating.

153 stocks of the 2800+ we cover are classified as Basic Materials stocks.




