



ETF & Mutual Fund Rankings: Industrials Sector

The Industrials sector ranks eighth out of the 11 sectors as detailed in our [3Q21 Sector Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Industrials sector ranked eighth as well. It gets our Neutral rating, which is based on an aggregation of ratings of the 407 stocks in the Industrials sector as of July 11, 2021. See a recap of our [2Q21 Sector Ratings here](#).

Figures 1 and 2 show the best and worst rated ETFs and mutual funds in the sector. Not all Industrials sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 21 to 359). This variation creates drastically different investment implications and, therefore, ratings.

PKB is the top-rated Industrials ETF and FSRFX is the top-rated Industrials mutual fund. PKB earns a Very Attractive rating and FSRFX earns a Neutral rating.

JETS is the worst rated Industrials ETF and FCLAX is the worst Industrials mutual fund. They both earn a Very Unattractive rating.

407 stocks of the 2800+ we cover are classified as Industrials stocks.

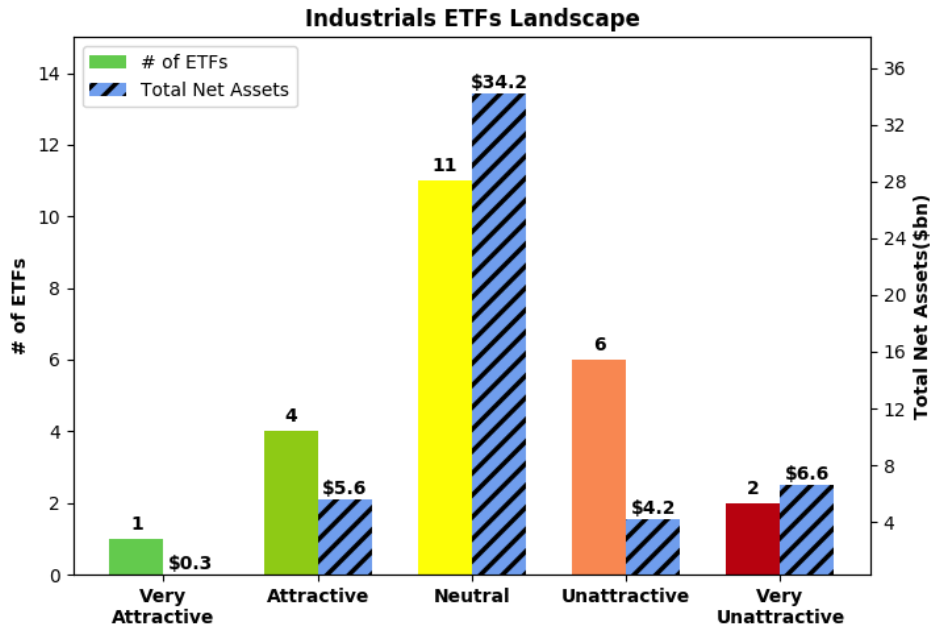

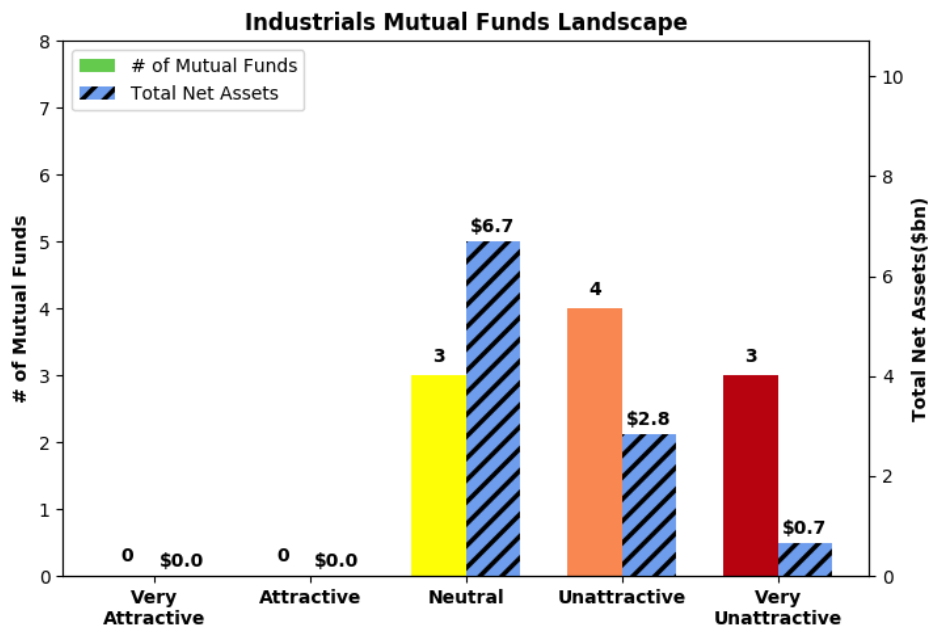
