

ETF & Mutual Fund Rankings: Small Cap Value Style

The Small Cap Value style ranks seventh out of the twelve fund styles as detailed in our <u>3Q21 Style Ratings for</u> <u>ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Small Cap Value style ranked ninth. It gets our Neutral rating, which is based on an aggregation of ratings of 19 ETFs and 193 mutual funds in the Small Cap Value style as of July 14, 2021. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Small Cap Value style ETFs and mutual funds are created the same. The number of holdings varies widely (from 14 to 1,507). This variation creates drastically different investment implications and, therefore, ratings.

Wisdom Tree U.S. Small Cap Dividend Fund ETF (DES) is the top-rated Small Cap Value ETF and Dean Small Cap Value Fund (DASCX) is the top-rated Small Cap Value mutual fund. Both earn a Very Attractive rating.

iShares Russell 2000 Value ETF (IWN) is the worst rated Small Cap Value ETF and Putnam Small Cap Value Fund (PSLAX) is the worst rated Small Cap Value mutual fund. IWN earns an Unattractive rating and PSLAX earns a Very Unattractive rating.

Put another way, research on fund holdings is necessary due diligence because a fund's performance is only as good as its holdings' performance. 


