Don't Trust Mutual Fund Labels

There are at least 842 different All Cap Value mutual funds and at least 5,372 mutual funds across twelve styles. Do investors need 447+ choices on average per style? How different can the mutual funds be?

Those 842 All Cap Value mutual funds are very different. With anywhere from 15 to 3,092 holdings, many of these All Cap Value mutual funds have drastically different portfolios, creating drastically different investment implications.

The same is true for the mutual funds in any other style, as each offers a very different mix of good and bad stocks. All Cap Value ranks first for stock selection. Small Cap Growth ranks last. Details on the Best & Worst mutual funds in each style are here.

How to Avoid Paralysis by Analysis

We think the large number of All Cap Value (or any other) style mutual funds hurts investors more than it helps because too many options can be paralyzing. It is simply not possible for the majority of investors to properly assess the quality of so many mutual funds. Analyzing mutual funds, done with the proper diligence¹, is far more difficult than analyzing stocks because it means analyzing all the stocks within each mutual fund. As stated above, that can be as many as 3,092 stocks, and sometimes even more, for one mutual fund.

Anyone focused on <u>fulfilling the fiduciary duty of care</u> recognizes that analyzing the holdings² of a mutual fund is critical to finding the best mutual fund. More reliable & <u>proprietary</u> fundamental data, as shown in <u>The Journal of Financial Economics</u> and proven to generate <u>novel alpha</u>, drives our research and analysis of fund holdings. Figure 1 shows our top rated mutual fund for each style.

Amongst the mutual funds in Figure 1, Hennessy Cornerstone Large Growth Fund (HILGX) ranks first overall, Royce Small Cap Value Fund (RVVHX) ranks second, and DWS CROCI Equity Dividend Fund (KDHTX) ranks third. Touchstone Mid Cap Fund (TMPRX) ranks last.

Hennessy Cornerstone Large Growth Fund (HILGX) is not only the top-rated All Cap Blend mutual fund but is also the overall top-rated style mutual fund out of the 5,372 style mutual funds that we cover.
