

ETF & Mutual Fund Rankings: Basic Materials Sector

The Basic Materials sector ranks first out of the 11 sectors as detailed in our <u>2Q22 Sector Ratings for ETFs and</u> <u>Mutual Funds</u> report. <u>Last quarter</u>, the Basic Materials sector ranked second. It gets our Very Attractive rating, which is based on an aggregation of ratings of the 146 stocks in the Basic Materials sector as of April 11, 2022. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Basic Materials sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 25 to 121). This variation creates drastically different investment implications and, therefore, ratings.

SLX is the top-rated Basic Materials ETF and VMIAX is the top-rated Basic Materials mutual fund. SLX earns a Very Attractive rating and VMIAX earns an Attractive rating.

PSCM is the worst rated Basic Materials ETF and FMFAX is the worst Basic Materials mutual fund. They both earn an Unattractive rating.

146 stocks of the 2700+ we cover are classified as Basic Materials stocks.




