



## ETF & Mutual Fund Rankings: Consumer Non-cyclicals Sector

The Consumer Non-cyclicals sector ranks second out of the 11 sectors as detailed in our [2Q22 Sector Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Consumer Non-cyclicals sector ranked third. It gets our Attractive rating, which is based on an aggregation of ratings of the 140 stocks in the Consumer Non-cyclicals sector as of April 11, 2022. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Consumer Non-cyclicals sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 30 to 129). This variation creates drastically different investment implications and, therefore, ratings.

KXI is the top-rated Consumer Non-cyclicals ETF and VCSAX is the top-rated Consumer Non-cyclicals mutual fund. Both earn a Very Attractive rating.

FSAVX is the worst rated Consumer Non-cyclicals mutual fund. FSAVX earns a Neutral rating.

140 stocks of the 2700+ we cover are classified as Consumer Non-cyclicals stocks.

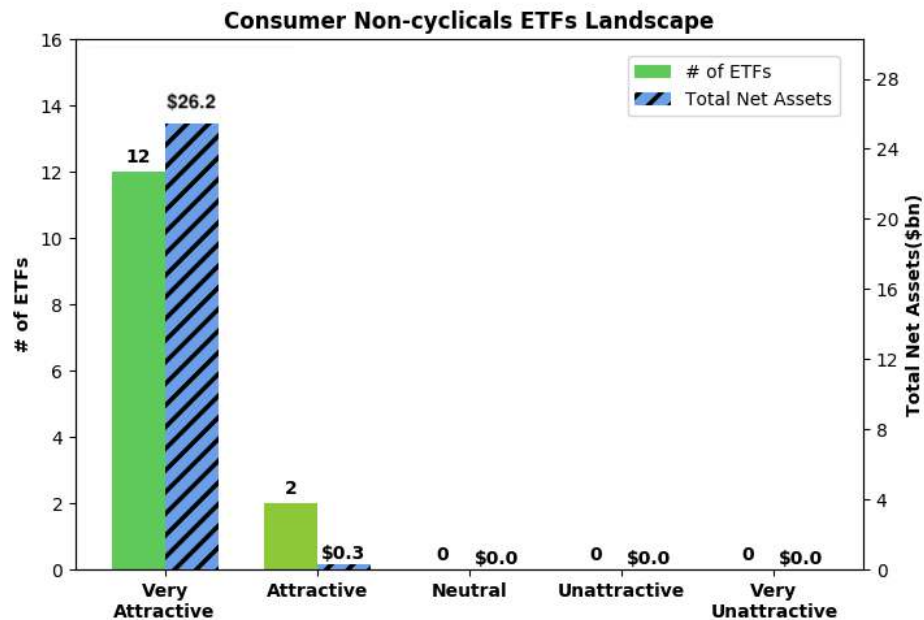

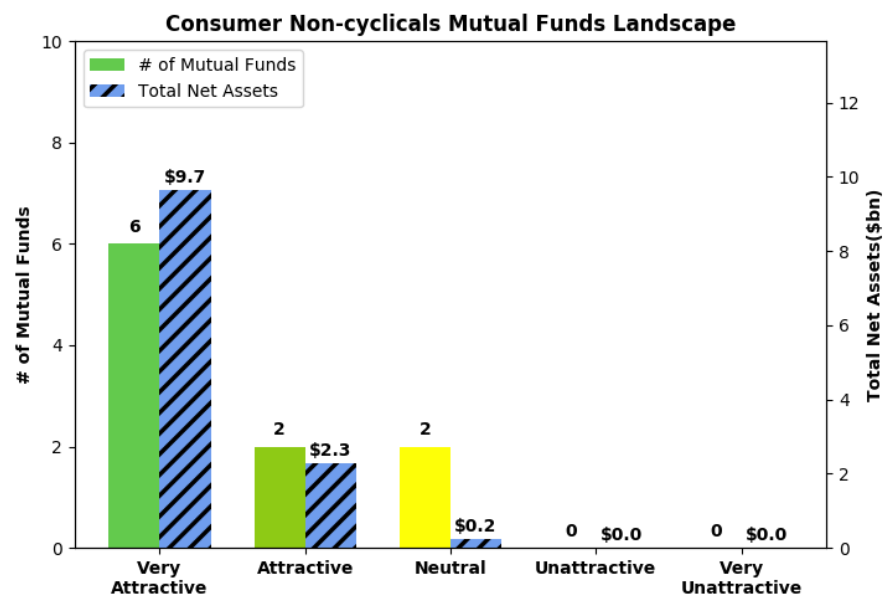
