ETF & Mutual Fund Rankings: Consumer Non-cyclicals Sector

The Consumer Non-cyclicals sector ranks second out of the 11 sectors as detailed in our <u>2Q22 Sector Ratings</u> for ETFs and Mutual Funds report. <u>Last quarter</u>, the Consumer Non-cyclicals sector ranked third. It gets our Attractive rating, which is based on an aggregation of ratings of the 140 stocks in the Consumer Non-cyclicals sector as of April 11, 2022. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Consumer Non-cyclicals sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 30 to 129). This variation creates drastically different investment implications and, therefore, ratings.




