



ETF & Mutual Fund Rankings: Energy Sector

The Energy sector ranks fifth out of the 11 sectors as detailed in our [2Q22 Sector Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Energy sector ranked tenth. It gets our Neutral rating, which is based on an aggregation of ratings of the 152 stocks in the Energy sector as of April 11, 2022. See a recap of our [1Q22 Sector Ratings here](#).

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Energy sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 16 to 113). This variation creates drastically different investment implications and, therefore, ratings.

XES is the worst rated Energy ETF and GHAAX is the worst Energy mutual fund. They both earn a Very Unattractive rating.

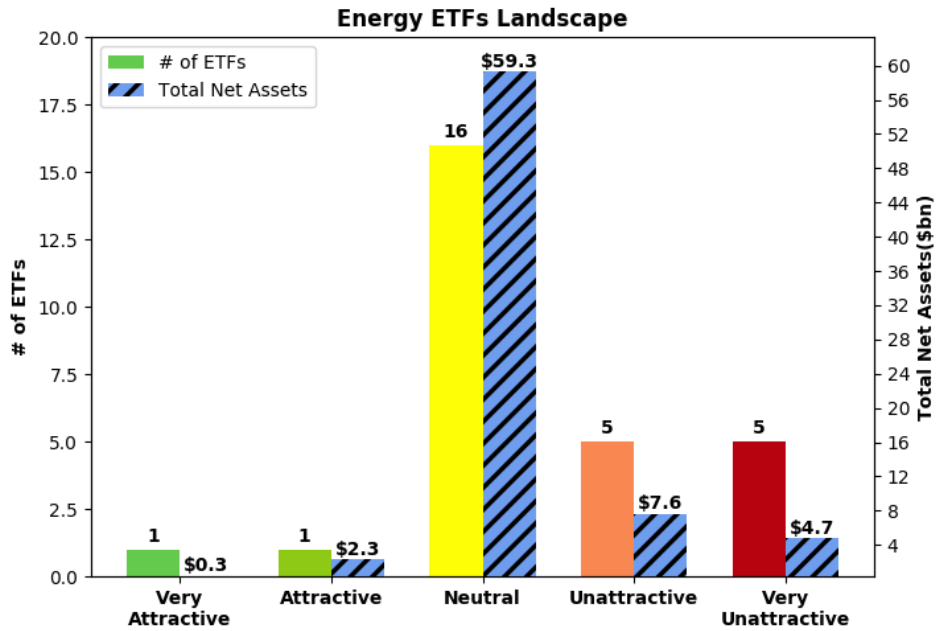

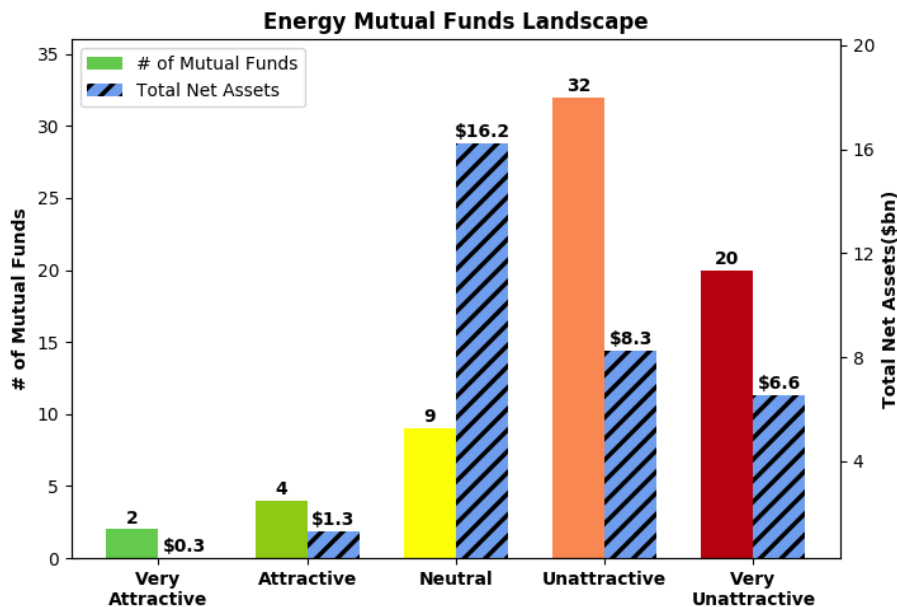
