ETF & Mutual Fund Rankings: Healthcare Sector

The Healthcare sector ranks sixth out of the 11 sectors as detailed in our QQ22 Sector Ratings for ETFs and Mutual Funds report. Last quarter, the Healthcare sector ranked fifth. It gets our Neutral rating, which is based on an aggregation of ratings of the 348 stocks in the Healthcare sector as of April 11, 2022. See a recap of our 1Q22 Sector Ratings here.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Healthcare sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 25 to 471). This variation creates drastically different investment implications and, therefore, ratings.

LOGSX is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

IHE is the top-rated Healthcare ETF and SWHFX is the top-rated Healthcare mutual fund. Both earn a Very Attractive rating.

GNOM is the worst rated Healthcare ETF and MSVEX is the worst Healthcare mutual fund. They both earn a Very Unattractive rating.

348 stocks of the 2700+ we cover are classified as Healthcare stocks.




