

# **How to Avoid the Worst Style Mutual Funds**

Question: Why are there so many mutual funds?

Answer: Mutual fund management is profitable, so Wall Street creates more products to sell.

The large number of mutual funds has little to do with serving your best interests. More <u>reliable</u> & <u>proprietary</u> fundamental data, proven in <u>The Journal of Financial Economics</u>, drives our research and analysis of fund holdings and provides investors with a <u>new source of alpha</u>. We leverage this data to identify two red flags you can use to avoid the worst mutual funds:

### 1. High Fees

Mutual funds should be cheap, but not all of them are. The first step is to benchmark what cheap means.

To ensure you are paying at or below average fees, invest only in mutual funds with <u>total annual costs</u> below 1.63% - the average total annual cost of the 5,810 U.S. equity Style mutual funds we cover. The weighted average is lower at 0.90%, which highlights how investors tend to put their <u>money in mutual funds with low fees</u>.

Figure 1 shows American Growth Fund Series One (AMRBX) is the most expensive style mutual fund and Vanguard 500 Index Fund (VFFSX) is the least expensive. American Growth (AMRBX, AMRAX, AMRGX) provides three of the most expensive mutual funds while Vanguard (VFFSX, VSTSX, VIIX) mutual funds are among the cheapest.

Investors need not pay high fees for quality holdings.¹ Vanguard 500 Index Fund (VFFSX) is the best ranked style mutual fund in Figure 1. VFFSX's Neutral Portfolio Management rating and 0.02% total annual cost earn it an Attractive rating.² Hennessy Cornerstone Large Growth Fund (HILGX) is the best ranked style mutual fund

overall. HILGX's Very Attractive Portfolio Management rating and 1.30% total annual cost earn it a Very Attractive rating.

On the other hand, no matter how cheap a mutual fund, if it holds bad stocks, its performance will be bad. The quality of a mutual fund's holdings matters more than its price.

#### 2. Poor Holdings

Avoiding poor holdings is by far the hardest part of avoiding bad mutual funds, but it is also the most important because a mutual fund's performance is determined more by its holdings than its costs. Figure 2 shows the mutual funds within each style with the worst holdings or portfolio management ratings.

Morgan Stanley (MBIRX, MMCGX) and ProFunds (BLPIX, SLPIX) appear more often than any other providers in Figure 2, which means that they offer the most mutual funds with the worst holdings.

Morgan Stanley Discovery Portfolio (MMCGX) is the worst rated mutual fund in Figure 2. Morgan Stanley Insight Fund (MBIRX), ClearBridge Mid Cap Fund (LSIRX), Baillie Gifford U.S. Discovery Fund (BGUKX), Invesco Small Cap Value Fund (SMVX), Champlain Small Company Fund (CIPNX), ProFunds Small Cap Fund (SLPIX), Securian AM Real Asset Income Fund (VSDIX), and SEI Multi-Asset Capital Stability Fund (SMLYX) also earn a Very Unattractive predictive overall rating, which means not only do they hold poor stocks, they charge high total annual costs.

Our <u>overall ratings on mutual funds</u> are on our <u>stock ratings</u> of their holdings and the total annual costs of investing in the fund.

### The Danger Within

Buying a mutual fund without analyzing its holdings is like buying a stock without analyzing its business model and finances. Put another way, research on mutual fund holdings is necessary due diligence because a mutual fund's performance is only as good as its holdings.
