

# **ETF & Mutual Fund Rankings: Industrials Sector**

The Industrials sector ranks eighth out of the 11 sectors as detailed in our <u>2Q22 Sector Ratings for ETFs and</u> <u>Mutual Funds</u> report. <u>Last quarter</u>, the Industrials sector ranked fourth. It gets our Neutral rating, which is based on an aggregation of ratings of the 391 stocks in the Industrials sector as of April 11, 2022. See a recap of our <u>1Q22 Sector Ratings here</u>.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Industrials sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 22 to 363). This variation creates drastically different investment implications and, therefore, ratings.

PKB is the top-rated Industrials ETF and FARMX is the top-rated Industrials mutual fund. Both earn a Very Attractive rating.

ARKQ is the worst rated Industrials ETF and FCLAX is the worst Industrials mutual fund. They both earn a Very Unattractive rating.

391 stocks of the 2700+ we cover are classified as Industrials stocks.


### PERFORMANCE OF HOLDINGs = PERFORMANCE OF FUND


