ETF & Mutual Fund Rankings: Large Cap Growth Style

The Large Cap Growth style ranks fifth out of the twelve fund styles as detailed in our <u>2Q22 Style Ratings for ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Large Cap Growth style ranked fifth as well. The category receives our Neutral rating, which is based on an aggregation of ratings of 39 ETFs and 753 mutual funds in the Large Cap Growth style as of April 14, 2022. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Large Cap Growth style ETFs and mutual funds are created the same. The number of holdings varies widely (from 22 to 664). This variation creates drastically different investment implications and, therefore, ratings.

Steward Large Cap Growth Fund (SJGIX) and Fiera Capital U.S. Equity Long-Term Quality Fund (FCUIX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

Fidelity Stocks for Inflation (FCPI) is the top-rated Large Cap Growth ETF and Fidelity SAI U.S. Quality Index Fund (FUQIX) is the top-rated Large Cap Growth mutual fund. Both earn a Very Attractive rating.

American Century Focused Dynamic Growth ETF (FDG) is the worst rated Large Cap Growth ETF and Pinnacle Sherman Breakaway Strategy Fund (APTRX) is the worst rated Large Cap Growth mutual fund. FDG earns an Unattractive rating and APTRX earns a Very Unattractive rating.

Put another way, research on fund holdings is necessary due diligence because a fund's performance is only as good as its holdings' performance. 

Figure 3: Separating the Best ETFs from the Worst Funds


Large Cap Growth ETF Landscape
