

# ETF & Mutual Fund Rankings: Large Cap Value Style

The Large Cap Value style ranks first out of the twelve fund styles as detailed in our <u>2Q22 Style Ratings for ETFs</u> and <u>Mutual Funds</u> report. <u>Last quarter</u>, the Large Cap Value style ranked fourth. The category receives our Very Attractive rating, which is based on an aggregation of ratings of 29 ETFs and 346 mutual funds in the Large Cap Value style as of April 19, 2022. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Large Cap Value style ETFs and mutual funds are created the same. The number of holdings varies widely (from 19 to 934). This variation creates drastically different investment implications and, therefore, ratings.

Avantis U.S. Large Cap Value ETF (AVLV) is the top-rated Large Cap Value ETF and Manning & Napier Disciplined Value Series (MDVWX) is the top-rated Large Cap Value mutual fund. Both earn a Very Attractive rating.

AdvisorShares DoubleLine Value Equity ETF (DBLV) is the worst rated Large Cap Value ETF and Allspring Classic Value Fund (EIVAX) is the worst rated Large Cap Value mutual fund. DBLV earns a Neutral rating and EIVAX earns an Unattractive rating.

Put another way, research on fund holdings is necessary due diligence because a fund's performance is only as good as its holdings' performance. ### Figure 3: Separating the Best ETFs from the Worst Funds







Figure 4: Separating the Best Mutual Funds from the Worst Funds
