ETF & Mutual Fund Rankings: Mid Cap Growth Style

The Mid Cap Growth style ranks ninth out of the twelve fund styles, as detailed in our 2022-Style Ratings for ETFs and Mutual Funds report. Last quarter, the Mid Cap Growth style ranked eleventh. The category receives our Neutral rating, which is based on an aggregation of ratings of 20 ETFs and 320 mutual funds in the Mid Cap Growth style as of April 20, 2022. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Mid Cap Growth style ETFs and mutual funds are created the same. The number of holdings varies widely (from 23 to 3,607). This variation creates drastically different investment implications and, therefore, ratings.

Barron's 400 ETF (BFOR) is the top-rated Mid Cap Growth ETF and Commerce Mid Cap Growth Fund (CFAGX) is the top-rated Mid Cap Growth mutual fund. BFOR earns a Very Attractive rating and CFAGX earns an Attractive rating.

Nuveen ESG Mid Cap Growth ETF (NUMG) is the worst rated Mid Cap Growth ETF and Calamos Timpani SMID Growth Fund (CTAGX) is the worst rated Mid Cap Growth mutual fund. NUMG earns an Unattractive rating and CTAGX earns a Very Unattractive rating.



Figure 3: Separating the Best ETFs from the Worst Funds


Mid Cap Growth ETF Landscape
