



ETF & Mutual Fund Rankings: Small Cap Blend Style

The Small Cap Blend style ranks eighth out of the twelve fund styles, as detailed in our [2Q22 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Small Cap Blend style ranked ninth. The category receives our Neutral rating, which is based on an aggregation of ratings of 66 ETFs and 670 mutual funds in the Small Cap Blend style as of April 19, 2022. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Small Cap Blend style ETFs and mutual funds are created the same. The number of holdings varies widely (from 21 to 2,590). This variation creates drastically different investment implications and, therefore, ratings.

James Micro Cap Fund (JMCRX) is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

Pacer U.S. Small Cap Cash Cows 100 ETF (CALF) is the top-rated Small Cap Blend ETF and Royce Small Cap Value Fund (RVVHX) is the top-rated Small Cap Blend mutual fund. Both earn a Very Attractive rating.

Nuveen Small Cap Select ETF (NSCS) is the worst rated Small Cap Blend ETF and Nuveen Small Cap Select Fund (EMGRX) is the worst rated Small Cap Blend mutual fund. Both earn a Very Unattractive rating.

Put another way, research on fund holdings is necessary due diligence because a fund’s performance is only as good as its holdings’ performance. 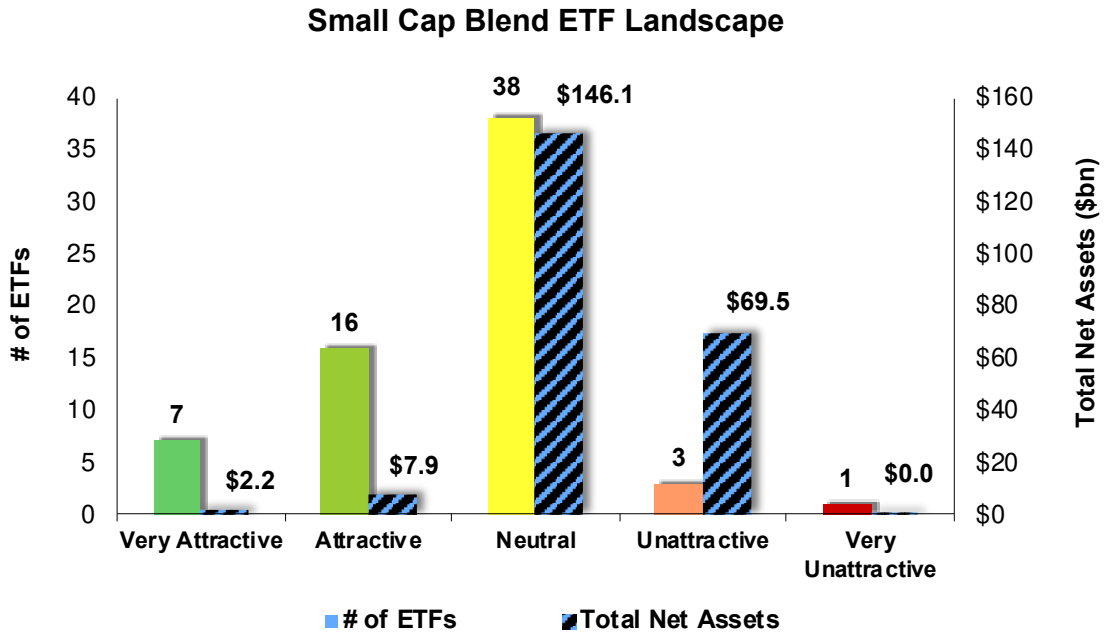

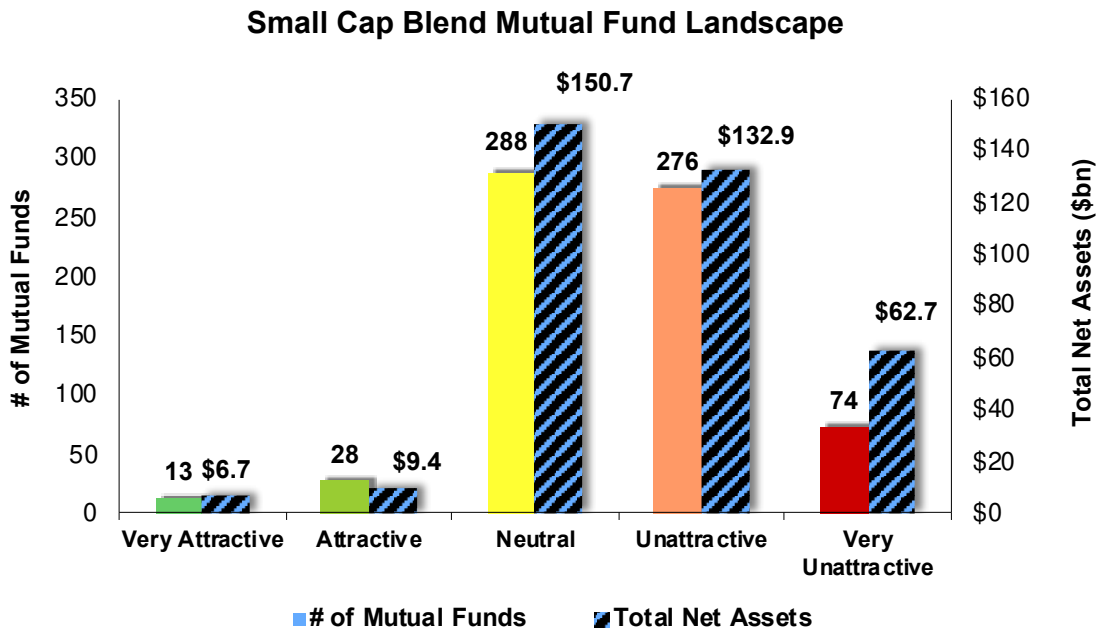
