


Focus List Stocks Underperform as a Long/Short Portfolio in 1Q23

Our uniquely rigorous research paid off for clients in 2022 despite getting off to a slower start in 2023.

Our Focus List Stocks: Long Model Portfolio, the best of our Long Ideas, and our Focus List Stocks: Short Model Portfolio, the best of our Danger Zone picks, underperformed the S&P 500¹ by a combined 10% as a long/short portfolio in 1Q23. The long portfolio contributed -3.5% while the short portfolio contributed -7% of the underperformance vs. the S&P 500 in 1Q23. 
