



3Q24 Filing Season: Created \$2.6 Million in Value

During 3Q24 filing season, we parsed 2,917 filings and created \$2,625,300¹ of value for clients. See Figure 1.

These filings tend to come in large bunches, which we call [Filing Season](#). The 3Q24 Filing Season is primarily when companies with 12/31 fiscal year ends file 10-Qs for their third quarter earnings.
