Don't Trust Mutual Fund Labels

There are at least 914 different All Cap Value mutual funds and at least 5,732 mutual funds across twelve styles. Do investors need 477+ choices on average per style? How different can the mutual funds be?

Those 914 All Cap Value mutual funds are very different. With anywhere from 14 to 957 holdings, many of these All Cap Value mutual funds have drastically different portfolios with differing risk profiles and performance outlooks.

The same is true for the mutual funds in any other style, as each offers a very different mix of good and bad stocks. All Cap Value ranks first for stock selection. Small Cap Growth ranks last. Details on the [Best & Worst mutual funds in each style are here](#).

Avoiding Analysis Paralysis

We think the large number of style mutual funds hurts investors more than it helps. Manually conducting a deep analysis for every fund is simply not a realistic option, exposing investors to insufficient analysis and missing profitable opportunities. Analyzing mutual funds, with the proper diligence¹, is far more difficult than analyzing stocks because it means analyzing all the stocks within each mutual fund. As stated above, there can be as many as 957 stocks or more for one mutual fund.

Anyone focused on [fulfilling the fiduciary duty of care](#) recognizes that analyzing the holdings² of a mutual fund is critical to finding the best mutual fund. More [reliable](#) & [proprietary](#) fundamental data, proven in [The Journal of Financial Economics](#), drives our research and analysis of fund holdings and provides investors with a [new source of alpha](#). Amongst the mutual funds in Figure 1, GMO U.S. Opportunistic Value Fund (UOAX) ranks first overall, Steward International Enhanced Index Fund (SNTFX) ranks second, and Harbor Mid Cap Value Fund (HNMVX) ranks third. DFA Investment Dimensions U.S. Large Cap Growth Portfolio (DUSLX) ranks last.

The worst mutual fund in Figure 1 is DFA Investment Dimensions U.S. Large Cap Growth Portfolio (DUSLX), which gets an Attractive rating.
