# **How to Find the Best Style Mutual Funds**

With an ever-growing list of similar-sounding mutual funds to choose from, finding the best is an increasingly difficult task. How can investors change the game to shift the odds in their favor?

#### **Don't Trust Mutual Fund Labels**

There are at least 1,386 different Large Cap Growth mutual funds and at least 6,027 mutual funds across ten styles. Do investors need 602+ choices on average per style? How different can the mutual funds be?

Those 1,386 Large Cap Growth mutual funds are very different. With anywhere from 18 to 2,714 holdings, many of these Large Cap Growth mutual funds have drastically different portfolios with differing risk profiles and performance outlooks.

The same is true for the mutual funds in any other style, as each offers a very different mix of good and bad stocks. Large Cap Value ranks first for stock selection. Small Cap Growth ranks last. ## **Avoiding Analysis Paralysis**

We think the large number of style mutual funds hurts investors more than it helps. Manually conducting a deep analysis for every fund is simply not a realistic option, exposing investors to insufficient analysis and missing profitable opportunities. Analyzing mutual funds, with the proper diligence<sup>1</sup>, is far more difficult than analyzing stocks because it means analyzing all the stocks within each mutual fund. As stated above, there can be as many as 2,714 stocks or more for one mutual fund.

Anyone focused on <u>fulfilling the fiduciary duty of care</u> recognizes that analyzing the holdings<sup>2</sup> of a mutual fund is critical to finding the best mutual fund. More <u>reliable</u> & <u>proprietary</u> fundamental data, proven in <u>The Journal of Financial Economics</u>, drives our research and analysis of fund holdings and provides investors with a <u>new source of alpha</u>. Figure 1 shows our top rated mutual fund for each style.

Amongst the mutual funds in Figure 1, Beutel Goodman Large Cap Value Fund (BVALX) ranks first overall, Vanguard U.S. Multifactor Fund (VFMFX) ranks second, and Fuller & Thaler Behavioral Small Cap Equity Fund (FTHFX) ranks third. AQR Large Cap Defensive Style Fund (QUERX) ranks last.

You need to be sure you do not buy a fund that might blow up. Buying a fund without analyzing its holdings is like buying a stock without analyzing its business and finances. Beutel Goodman Large Cap Value Fund (BVALX) is not only the top-rated Large Cap Value mutual fund, but is also the overall top-ranked style mutual fund out of the 6,027 style mutual funds that we cover.

The worst mutual fund in Figure 1 is AQR Large Cap Defensive Style Fund (QUERX), which also gets a Very Attractive rating.
