Don't Trust Mutual Fund Labels

There are at least 164 different Technology mutual funds and at least 689 mutual funds across eleven sectors. Do investors need 62+ choices on average per sector? How different can the mutual funds be?

Those 164 Technology mutual funds are very different from each other. With anywhere 21 to 2,495 holdings, many of these Technology mutual funds have drastically different portfolios with differing risk profiles and performance outlooks.

The same is true for the mutual funds in any other sector, as each offers a very different mix of good and bad stocks. Telecom Services ranks first for stock selection. Utilities ranks last. Details on the [Best & Worst mutual funds in each sector are here.](#)

Avoiding Analysis Paralysis

We think the large number of sector mutual funds hurts investors more than it helps. Manually conducting a deep analysis for every fund is simply not a realistic option, exposing investors to insufficient analysis and missing profitable opportunities. Analyzing mutual funds, with the proper diligence¹, is far more difficult than analyzing stocks because it means analyzing all the stocks within each mutual fund. As stated above, there can be as many as 2,495 stocks or more for one mutual fund.

Anyone focused on [fulfilling the fiduciary duty of care](#) recognizes that analyzing the holdings² of a mutual fund is critical to finding the best mutual fund. More [reliable](#) & [proprietary](#) fundamental data, proven in [The Journal of Financial Economics](#), drives our research and analysis of fund holdings and provides investors with a [new source of alpha](#). Figure 1 shows our top rated mutual fund for each sector.

Amongst the mutual funds in Figure 1, Fidelity Advisor Series VII Financial Fund (FFSIX) ranks first overall, Vanguard Healthcare Index Fund (VHCIX) ranks second, and Tortoise Energy Infrastructure Total Return Fund (TORIX) ranks third. Vanguard Real Estate Index Fund (VGSNX) ranks last.

Fidelity Advisor Series VII Financial Fund (FFSIX) is not only the top-rated Financials mutual fund, but is also one of the top ranked sector mutual fund out of the 689 sector mutual funds that we cover.

The worst mutual fund in Figure 1 is Vanguard Real Estate Index Fund (VGSNX), which gets a Very Unattractive rating. One would think mutual fund providers could do better for this sector.
