



How to Avoid the Worst Style Mutual Funds

Question: Why are there so many mutual funds?

Answer: Mutual fund management is profitable, so Wall Street creates more products to sell.

The large number of mutual funds has little to do with serving your best interests as an investor. More [reliable](#) & [proprietary](#) fundamental data, proven in [The Journal of Financial Economics](#), drives our research and analysis of fund holdings and provides investors with a [new source of alpha](#). We leverage this data to identify two red flags you can use to avoid the worst mutual funds:

1. High Fees

Mutual funds should be cheap, but not all of them are. The first step is to benchmark what cheap means.

To ensure you are paying at or below average fees, invest only in mutual funds with [total annual costs](#) below 1.64% – the average total annual cost of the 5,764 U.S. equity Style mutual funds we cover. The weighted average of mutual funds we have assets under management data for is lower at 0.50%, which highlights how investors tend to put their [money in mutual funds with low fees](#).

Figure 1 shows American Growth Fund (AMRBX) is the most expensive style mutual fund and American Century ETF Trust (AVCNX) is the least expensive. American Growth provides four of the most expensive mutual funds while American Century and T. Rowe Price mutual funds are among the cheapest.

Investors need not pay high fees for quality holdings.¹ LSV Conservative Value Equity Fund (LSVVX) is one of the best ranked style mutual funds overall. LSVVX's Neutral [Portfolio Management rating](#) and 0.39% total annual cost earns it a Very Attractive rating.²

On the other hand, Fidelity Small Cap Index Fund (FSSNX) holds poor stocks and earns our Unattractive rating, yet has low total annual costs of 0.03%. No matter how cheap a mutual fund, if it holds bad stocks, its performance will be bad. The quality of a mutual fund's holdings matters more than its price.

2. Poor Holdings

Avoiding poor holdings is by far the hardest part of avoiding bad mutual funds, but it is also the most important because a mutual fund's performance is determined more by its holdings than its costs. Figure 2 shows the mutual funds within each style with the worst holdings or [portfolio management ratings](#).

T. Rowe Price appears more often than any other providers in Figure 2, which means that they offer the most mutual funds with the worst holdings.

Spirit of America Utilities Fund (SOIUX) is the worst rated mutual fund in Figure 2 based on our [predictive overall rating](#). Hood River Small Cap Growth Fund (HRSIX), T. Rowe Price New Horizons Fund (TRUZX), Morgan Stanley Global Insight Portfolio (MGZZX), AQR Macro Opportunities Fund (QGMRX), and Tarkio Fund (TARKX) also earn a Very Unattractive predictive overall rating, which means not only do they hold poor stocks, they charge high total annual costs.

Our [overall ratings on mutual funds](#) reflects our [stock ratings](#) of their holdings and a measure of the total annual costs of investing in the fund.

The Danger Within

Buying a mutual fund without analyzing its holdings is like buying a stock without analyzing its business model and finances. Put another way, research on mutual fund holdings is necessary due diligence because a mutual fund's performance is only as good as its holdings.
