Don't Trust Mutual Fund Labels

There are at least 1,291 different Large Cap Growth mutual funds and at least 5,764 mutual funds across ten styles. Do investors need 576+ choices on average per style? How different can the mutual funds be?

Those 1,291 Large Cap Growth mutual funds are very different. With anywhere from 14 to 2,944 holdings, many of these Large Cap Growth mutual funds have drastically different portfolios with differing risk profiles and performance outlooks.

The same is true for the mutual funds in any other style, as each offers a very different mix of good and bad stocks. Large Cap Blend ranks first for stock selection. Small Cap Growth ranks last. Details on the [Best & Worst mutual funds in each style are here](#).

Avoiding Analysis Paralysis

We think the large number of style mutual funds hurts investors more than it helps. Manually conducting a deep analysis for every fund is simply not a realistic option, exposing investors to insufficient analysis and missing profitable opportunities. Analyzing mutual funds, with the proper diligence¹, is far more difficult than analyzing stocks because it means analyzing all the stocks within each mutual fund. As stated above, there can be as many as 2,944 stocks or more for one mutual fund.

Anyone focused on [fulfilling the fiduciary duty of care](#) recognizes that analyzing the holdings² of a mutual fund is critical to finding the best mutual fund. More [reliable](#) & [proprietary](#) fundamental data, proven in [The Journal of Financial Economics](#), drives our research and analysis of fund holdings and provides investors with a [new source of alpha](#). Figure 1 shows our top rated mutual fund for each style.

Amongst the mutual funds in Figure 1, O'Shaughnessy Market Leaders Value Fund (OFVIX) ranks first overall, Fuller & Thaler Behavioral Small Cap Equity Fund (FTHFX) ranks second, and FMI Large Cap Fund (FMIQX) ranks third. Horizon Funds Multi-Factor Small/Mid Cap Fund (HSMNX) ranks last.

The worst mutual fund in Figure 1 is Horizon Funds Multi-Factor Small/Mid Cap Fund (HSMNX), which gets an Attractive rating.
